

TIPS VENDOR AGREEMENT

TIPS RFP 230901 Audio Visual Equipment, Supplies, and Services

The following Vendor Agreement (“Agreement”) creates a legal agreement between The Interlocal Purchasing System (“TIPS”), a government purchasing cooperative and Department of Texas Region 8 Education Service Center and (INSERT ENTITY NAME):

its owners, agents, subsidiaries, and affiliates (together, “Vendor”) (individually, “Party”, and collectively the “Parties”) and this agreement shall exclusively govern the contractual relationship (“Agreement”) between the Parties.

TIPS, a governmental entity and a national purchasing cooperative seeks to provide a valuable and necessary solution to public entities and qualifying non-profits by performing the public procurement solicitation process and awarding compliant contracts to qualified vendors. Then, where the law of a customer’s jurisdiction allows, instead of public entities and qualifying non-profits expending time, money, and resources on the extensive public procurement process, the use of TIPS allows public entities to quickly select and purchase their preferred products or services from qualified, competitively evaluated vendors through cooperative purchasing.

1. **Purpose.** The purpose of this Agreement is to identify the terms and conditions of the relationship between TIPS and Vendor. Public entities and qualifying non-profits that properly join or utilize TIPS (“TIPS Members”) may elect to “piggyback” off of TIPS’ procurements and agreements where the laws of their jurisdiction allow. TIPS Members are not contractual parties to this Agreement although terms and conditions of this Agreement may ensure benefits to TIPS Members.
2. **Authority.** The Parties agree that the signatories below are individual authorized to enter into this Agreement on behalf of their entity and that they are acting under due and proper authority under applicable law.
3. **Definitions.**
 - a. **TIPS Pricing:** The specific pricing, discounts, and other pricing terms and incentives which Vendor submitted and TIPS approved for each respective TIPS Contract awarded to Vendor and all permissible, subsequent pricing updates submitted by Vendor and accepted by TIPS, if any.
 - b. **Authorized Reseller:** A reseller or dealer authorized and added by a Vendor through their online TIPS Vendor Portal to make TIPS sales according to the terms and conditions herein.
4. **Entire Agreement.** This Agreement resulted from TIPS posting a “TIPS Solicitation” (RFP, RCSP, RFQ, or other) and Vendor submitting a proposal in response to that posted TIPS Solicitation for evaluation and award. The Parties agree that this Agreement consists of the provisions set forth herein and: (1) The TIPS solicitation document resulting in this Agreement; (2) Any addenda or clarifications issued in relation to the TIPS solicitation; (3) All solicitation information provided to Vendor by TIPS through the TIPS eBid System; (3) Vendor’s entire proposal response to the TIPS solicitation including all accepted required attachments, acknowledged notices and certifications, accepted negotiated terms, pricing, accepted responses to questions, and accepted written clarifications of Vendor’s proposal, and; any properly included attachments to this Agreement. All documentation and information listed is hereby incorporated by reference as if set forth herein verbatim. In the event of conflict between the terms herein and one of the incorporated documents the terms and conditions herein shall control.
5. **Vendor’s Specific Warranties, Terms, and License Agreements.** Because TIPS serves public entities and non-profits throughout the nation all of which are subject to specific laws and policies of their jurisdiction, as a matter of standard practice, TIPS does not typically accept a Vendor’s specific “Sale Terms” (warranties, license agreements, master agreements, terms and conditions, etc.) on behalf of all TIPS Members. TIPS may permit Vendor to attach those to this Agreement to display to interested customers what terms may apply to their Supplemental Agreement with Vendor (if submitted by Vendor for that purpose). However, unless this term of the Agreement is negotiated and modified to state otherwise, those specific Sale Terms are not accepted by TIPS on behalf of all TIPS Members and each Member may choose whether to accept, negotiate, or reject those specific Sale Terms, which must be reflected in a separate agreement between Vendor and the Member in order to be effective.

- 6. Vendor Identity and Contact Information.** It is Vendor's sole responsibility to ensure that all identifying vendor information (name, EIN, d/b/a's, etc.) and contact information is updated and current at all times within the TIPS eBid System and the TIPS Vendor Portal. It is Vendor's sole responsibility to confirm that all e-correspondence issued from tips-usa.com, ionwave.net, and tipsconstruction.com to Vendor's contacts are received and are not blocked by firewall or other technology security. Failure to permit receipt of correspondence from these domains and failure to keep vendor identity and contact information current at all times during the life of the contract may cause loss of TIPS Sales, accumulating TIPS fees, missed rebid opportunities, lapse of TIPS Contract(s), and unnecessary collection or legal actions against Vendor. It is no defense to any of the foregoing or any breach of this Agreement that Vendor was not receiving TIPS' electronic communications issued by TIPS to Vendor's listed contacts.
- 7. Initiation of TIPS Sales.** When a public entity initiates a purchase with Vendor, if the Member inquires verbally or in writing whether Vendor holds a TIPS Contract, it is the duty of the Vendor to verify whether the Member is seeking a TIPS purchase. Once verified, Vendor must include the TIPS Contract Number on all purchase communications and sales documents exchanged with the TIPS Member.
- 8. TIPS Sales and Supplemental Agreements.** The terms of the specific TIPS order, including but not limited to: shipping, freight, insurance, delivery, fees, bonding, cost, delivery expectations and location, returns, refunds, terms, conditions, cancellations, order assistance, etc., shall be controlled by the purchase agreement (Purchase Order, Contract, Invoice, etc.) (hereinafter "Supplemental Agreement") entered into between the TIPS Member Customer and Vendor only. TIPS is not a party to any Supplemental Agreement. All Supplemental Agreements shall include Vendor's Name, as known to TIPS, and TIPS Contract Name and Number. Vendor accepts and understands that TIPS is not a legal party to TIPS Sales and Vendor is solely responsible for identifying fraud, mistakes, unacceptable terms, or misrepresentations for the specific order prior to accepting. Vendor agrees that any order issued from a customer to Vendor, even when processed through TIPS, constitutes a legal contract between the customer and Vendor only. When Vendor accepts or fulfills an order, even when processed through TIPS, Vendor is representing that Vendor has carefully reviewed the order for legality, authenticity, and accuracy and TIPS shall not be liable or responsible for the same. In the event of a conflict between the terms of this TIPS Vendor Agreement and those contained in any Supplemental Agreement, the provisions set forth herein shall control unless otherwise agreed to and authorized by the Parties in writing within the Supplemental Agreement.
- 9. Right of Refusal.** Vendor has the right not to sell to a TIPS Member under the awarded agreement at Vendor's discretion unless otherwise required by law.
- 10. Reporting TIPS Sales.** Vendor must report all TIPS Sales to TIPS. If a TIPS sale is initiated by Vendor receiving a TIPS Member's purchase order from TIPS directly, Vendor may consider that specific TIPS Sale reported. Otherwise, with the exception of TIPS Automated Vendors, who have signed an exclusive agreement with TIPS regarding reporting, all TIPS Sales must be reported to TIPS by either: (1) Emailing the purchase order or similar purchase document (with Vendor's Name, as known to TIPS, and the TIPS Contract Name and Number included) to TIPS at tipspo@tips-usa.com with "Confirmation Only" in the subject line of the email within three business days of Vendor's acceptance of the order, or; (2) Within 3 business days of the order being accepted by Vendor, Vendor must login to the TIPS Vendor Portal and successfully self-report all necessary sale information within the Vendor Portal and confirm that it shows up accurately on your current Vendor Portal statement. No other method of reporting is acceptable unless agreed to by the Parties in writing. Failure to report all sales pursuant to this provision may result in immediate cancellation of Vendor's TIPS Contract(s) for cause at TIPS' sole discretion. Please refer to the TIPS [Accounting FAQ's](#) for more information about reporting sales and if you have further questions, contact the Accounting Team at accounting@tips-usa.com.
- 11. TIPS Administration Fees.** The collection of administrative fees by TIPS, a government entity, for performance of these procurement services is required pursuant to Texas Government Code Section 791.011 et. seq. The administration fee ("TIPS Administration Fee") is the amount legally owed by Vendor to TIPS for TIPS Sales made by Vendor. The TIPS Administration Fee amount is typically a set percentage of the amount paid by the TIPS Member for each TIPS Sale, less shipping cost, bond cost, and taxes if applicable and identifiable, which is legally due to TIPS, but the exact TIPS Administration Fee for this Contract is published in the corresponding solicitation and is incorporated herein by reference. TIPS Administration Fees are due to TIPS immediately upon Vendor's receipt of payment, including partial payment, for a TIPS Sale. The TIPS Administration Fee is assessed on the amount paid by the TIPS Member, not on the Vendor's cost or on the amount for which the Vendor sold the item to a dealer or Authorized Reseller. Upon receipt of payment for a TIPS Sale, including partial payment (which renders TIPS Administration Fees immediately due), Vendor shall issue to TIPS the corresponding TIPS Administration Fee payment as soon as possible but not later than thirty-one calendar days following Vendor's receipt of payment. Vendor shall pay TIPS via check unless otherwise agreed to by the Parties in writing. Vendor shall include clear documentation with the issued payment dictating to which sale(s) the amount should be applied. Vendor may create a payment report within their TIPS Vendor Portal which is the preferred documentation dictating to which TIPS Sale(s) the amount should be applied. Failure to pay all TIPS Administration Fees pursuant to this provision may result in immediate cancellation of Vendor's TIPS Contract(s) for cause at TIPS' sole discretion as well as the initiation of collection and legal actions by TIPS against Vendor to the extent permitted by law. Any overpayment of participation fees to TIPS by Vendor will be refunded to the Vendor

within ninety (90) days of receipt of notification if TIPS receives written notification of the overpayment not later than the expiration of six (6) months from the date of overpayment and TIPS determines that the amount was not legally due to TIPS pursuant to this agreement and applicable law. Any notification of overpayment received by TIPS after the expiration of six (6) months from the date that TIPS received the payment will render the overpayment non-refundable. Region 8 ESC and TIPS reserve the right to extend the six (6) month deadline if approved by the Region 8 ESC Board of Directors. TIPS reserves all rights under the law to collect TIPS Administration Fees due to TIPS pursuant to this Agreement.

- 12. Term of the Agreement.** This Agreement with TIPS is for approximately three years with a one-year, consecutive option for renewal as described herein. Renewal options are not automatic and shall only be effective if offered by TIPS at its sole discretion. If TIPS offers a renewal option, the Vendor will be notified via email issued to Vendor's then-listed Primary Contact. The renewal option shall be deemed accepted by Vendor unless Vendor notifies TIPS of its objection to the renewal option in writing and confirms receipt by TIPS.

Actual Effective Date: Agreement is effective upon signature by authorized representatives of both Parties. The Effective Date does not affect the "Term Calculation Start Date."

Term Calculation Start Date: To keep the contract term consistent for all vendors awarded under a single TIPS contract, Vendor shall calculate the foregoing term as starting on the last day of the month that "Award Notifications" are anticipated as published in the Solicitation, regardless of the actual Effective Date.

Example of Term Calculation Start Date: If the anticipated "Award Date" published in the Solicitation is May 22, 2023, but extended negotiations delay award until June 27, 2023 (Actual Effective Date), the Term Calculation Start Date shall be May 31, 2023 in this example.

Contract Expiration Date: To keep the contract term consistent for all vendors awarded under a single TIPS contract, the term expiration date shall be three-years from the Term Calculation Start Date.

Example of Contract Expiration Date: If the anticipated "Award Date" published in the Solicitation is May 22, 2023, but extended negotiations delay award until June 27, 2023 (Actual Effective Date), the Term Calculation Start Date shall be May 31, 2023 and the Contract Expiration Date of the resulting initial "three-year" term, (which is subject to an extension(s)) will be May 31, 2026 in this example.

Option(s) for Renewal: Any option(s) for renewal shall begin on the Contract Expiration Date, or the date of the expiration of the prior renewal term where applicable, and continue for the duration specified for the renewal option herein.

Example of Option(s) for Renewal: In this example, if TIPS offers a one-year renewal and the Contract Expiration Date is May 31, 2026, then the one-year renewal is effective from May 31, 2026 to May 31, 2027.

TIPS may offer to extend Vendor Agreements to the fullest extent the TIPS Solicitation resulting in this Agreement permits.

- 13. TIPS Pricing.** Vendor agrees and understands that for each TIPS Contract that it holds, Vendor submitted, agreed to, and received TIPS' approval for specific pricing, discounts, and other pricing terms and incentives which make up Vendor's TIPS Pricing for that TIPS Contract ("TIPS Pricing"). Vendor confirms that Vendor will not add the TIPS Administration Fee as a charge or line-item in a TIPS Sale. Vendor hereby certifies that Vendor shall only offer goods and services through this TIPS Contract if those goods and services are included in or added to Vendor's TIPS Pricing and approved by TIPS. TIPS reserves the right to review Vendor's pricing update requests as specifically as line-item by line-item to determine compliance. However, Vendor contractually agrees that all submitted pricing updates shall be within the original terms of the Vendor's TIPS Pricing (scope, proposed discounts, price increase limitations, and other pricing terms and incentives originally proposed by Vendor) such that TIPS may accept Vendors price increase requests as submitted without additional vetting at TIPS discretion. Any pricing quoted by Vendor to a TIPS Member or on a TIPS Quote shall never exceed Vendor's TIPS Pricing for any good or service offered through TIPS. TIPS Pricing price increases and modifications, if permitted, will be honored according to the terms of the solicitation and Vendor's proposal, incorporated herein by reference.

- 14. Indemnification of TIPS.** VENDOR AGREES TO INDEMNIFY, HOLD HARMLESS, AND DEFEND TIPS, TIPS MEMBERS, TIPS OFFICERS, TIPS EMPLOYEES, TIPS DIRECTORS, AND TIPS TRUSTEES (THE "TIPS INDEMNITEES") FROM AND AGAINST ALL CLAIMS AND SUITS BY THIRD-PARTIES FOR DAMAGES, INJURIES TO PERSONS (INCLUDING DEATH), PROPERTY DAMAGES, LOSSES, EXPENSES, FEES, INCLUDING COURT COSTS, ATTORNEY'S FEES, AND EXPERT FEES, ARISING OUT OF OR RELATING TO VENDOR'S PERFORMANCE UNDER THIS AGREEMENT (INCLUDING THE PERFORMANCE OF VENDOR'S OFFICERS, EMPLOYEES, AGENTS, AUTHORIZED RESELLERS, SUBCONTRACTORS, LICENSEES, OR INVITEES), REGARDLESS OF THE NATURE OF THE CAUSE OF ACTION, INCLUDING WITHOUT LIMITATION CAUSES OF ACTION BASED UPON COMMON, CONSTITUTIONAL, OR STATUTORY LAW OR BASED IN

WHOLE OR IN PART UPON ALLEGATIONS OF NEGLIGENT OR INTENTIONAL ACTS OR OMISSIONS ON THE PART OF VENDOR, ITS OFFICERS, EMPLOYEES, AGENTS, AUTHORIZED RESELLERS, SUBCONTRACTORS, LICENSEES, OR INVITEES. NO LIMITATION OF LIABILITY FOR DAMAGES FOR PERSONAL INJURY OR PROPERTY DAMAGE ARE PERMITTED OR AGREED TO BY TIPS. APART FROM THIS INDEMNIFICATION PROVISION REQUIRING INDEMNIFICATION OF THE TIPS INDEMNITEES' ATTORNEY'S FEES AS SET FORTH ABOVE, RECOVERY OF ATTORNEYS' FEES BY THE PREVAILING PARTY IS AUTHORIZED ONLY IF AUTHORIZED BY TEX. EDUC. CODE § 44.032(F).

15. **Indemnification and Assumption of Risk – Vendor Data.** VENDOR AGREES THAT IT IS VOLUNTARILY PROVIDING DATA (INCLUDING BUT NOT LIMITED TO: VENDOR INFORMATION, VENDOR DOCUMENTATION, VENDOR'S PROPOSALS, VENDOR PRICING SUBMITTED OR PROVIDED TO TIPS, TIPS CONTRACT DOCUMENTS, TIPS CORRESPONDENCE, VENDOR LOGOS AND IMAGES, VENDOR'S CONTACT INFORMATION, VENDOR'S BROCHURES AND COMMERCIAL INFORMATION, VENDOR'S FINANCIAL INFORMATION, VENDOR'S CERTIFICATIONS, AND ANY OTHER VENDOR INFORMATION OR DOCUMENTATION, INCLUDING WITHOUT LIMITATION SOFTWARE AND SOURCE CODE UTILIZED BY VENDOR, SUBMITTED TO TIPS BY VENDOR AND ITS AGENTS) ("VENDOR DATA") TO TIPS. FOR THE SAKE OF CLARITY, AND WITHOUT LIMITING THE BREADTH OF THE INDEMNITY OBLIGATIONS IN SECTION 14 ABOVE, VENDOR AGREES TO PROTECT, INDEMNIFY, AND HOLD THE TIPS INDEMNITEES HARMLESS FROM AND AGAINST ANY AND ALL LOSSES, CLAIMS, ACTIONS, DEMANDS, ALLEGATIONS, SUITS, JUDGMENTS, COSTS, EXPENSES, FEES, INCLUDING COURT COSTS, ATTORNEY'S FEES, AND EXPERT FEES AND ALL OTHER LIABILITY OF ANY NATURE WHATSOEVER ARISING OUT OF OR RELATING TO: (I) ANY UNAUTHORIZED, NEGLIGENT OR WRONGFUL USE OF, OR CYBER DATA BREACH INCIDENT AND VIRUSES OR OTHER CORRUPTING AGENTS INVOLVING, VENDOR'S DATA, PRICING, AND INFORMATION, COMPUTERS, OR OTHER HARDWARE OR SOFTWARE SYSTEMS, AND; (II) ALLEGATIONS OR CLAIMS THAT ANY VENDOR DATA INFRINGES ON THE INTELLECTUAL PROPERTY RIGHTS OF A THIRD-PARTY OR VENDOR.
16. **Procedures Related to Indemnification.** In the event that an indemnity obligation arises, Vendor shall pay all amounts set forth in Section 14 and 15 above (including any settlements) and – if it has accepted its indemnity obligation without qualification – control the legal defense to such claim or cause of action, including without limitation attorney selection, strategy, discovery, trial, appeal, and settlement, and TIPS shall, at Vendor's cost and expense (with respect to reasonable out of pocket costs and expenses incurred by TIPS which shall be reimbursed to TIPS by Vendor), provide all commercially reasonable assistance requested by Vendor. In controlling any defense, Vendor shall ensure that all assertions of governmental immunity and all applicable pleas and defenses shall be promptly asserted.
17. **Indemnity for Underlying Sales and Supplemental Agreements.** Vendor shall be solely responsible for any customer claims or any disputes arising out of TIPS Sales or any Supplemental Agreement as if sold in the open-market. The Parties agree that TIPS shall not be liable for any claims arising out of Vendor's TIPS Sales or Supplemental Agreements, including but not limited to: allegations of product defect or insufficiency, allegations of service defect or insufficiency, allegations regarding delivery defect or insufficiency, allegations of fraud or misrepresentation, allegations regarding pricing or amounts owed for TIPS sales, and/or allegations regarding payment, over-payment, under-payment, or non-payment for TIPS Sales. Payment/Drafting, overpayment/over-drafting, under-payment/under-drafting, or non-payment for TIPS Sales between customer and Vendor and inspections, rejections, or acceptance of such purchases shall be the exclusive respective obligations of Vendor/Customer, and disputes shall be handled in accordance with the terms of the underlying Supplemental Agreement(s) entered into between Vendor and Customer. Vendor acknowledges that TIPS is not a dealer, subcontractor, agent, or reseller of Vendor's goods and services and shall not be responsible for any claims arising out of alleged insufficiencies or defects in Vendor's goods and services, should any arise.
18. **Confidentiality of Vendor Data.** Vendor understands and agrees that by signing this Agreement, all Vendor Data is hereby released to TIPS, TIPS Members, and TIPS third-party administrators to effectuate Vendor's TIPS Contract except as provided for herein. The Parties agree that Vendor Data is accessible by all TIPS Members as if submitted directly to that TIPS Member Customer for purchase consideration. If Vendor otherwise considers any portion of Vendor's Data to be confidential and not subject to public disclosure pursuant to Chapter 552 Texas Gov't Code (the "Public Information Act") or other law(s) and orders, Vendor must have identified the claimed confidential materials through proper execution of the Confidentiality Claim Form which is required to be submitted as part of Vendor's proposal resulting in this Agreement and incorporated by reference. The Confidentiality Claim Form included in Vendor's proposal and incorporated herein by reference is the sole indicator of whether Vendor considers any Vendor Data confidential in the event TIPS receives a Public Information Request. If TIPS receives a request, any responsive documentation not deemed confidential by you in this manner will be automatically released. For Vendor Data deemed confidential by you in this manner, TIPS will follow procedures of controlling statute(s) regarding any claim of confidentiality and shall not be liable for any release of information required by law, including Attorney General determination and opinion. In the event that TIPS receives a written request for information pursuant to the Public Information Act that affects Vendor's interest in any information or data furnished to TIPS by Vendor, and TIPS requests an opinion from the Attorney General, Vendor may, at its own option and expense, prepare comments and submit information directly to the Attorney General stating why the requested information is exempt from disclosure pursuant to the requirements of the Public Information Act. Vendor is solely responsible for submitting the memorandum brief and information to the Attorney General

within the time period prescribed by the Public Information Act. Notwithstanding any other information provided in this solicitation or Vendor designation of certain Vendor Data as confidential or proprietary, Vendor's acceptance of this TIPS Vendor Agreement constitutes Vendor's consent to the disclosure of Vendor's Data, including any information deemed confidential or proprietary, to TIPS Members or as ordered by a Court or government agency, including without limitation the Texas Attorney General. Vendor agrees that TIPS shall not be responsible or liable for any use or distribution of information or documentation by TIPS Members or as required by law.

- 19. Vendor's Authorized Resellers.** TIPS recognizes that many vendors operate in the open market through the use of resellers or dealers. For that reason, TIPS permits Vendor to authorize Authorized Resellers within its Vendor Portal and make TIPS Sales through the Authorized Reseller(s). Once authorized by Vendor in the Vendor Portal, the Authorized Reseller(s) may make TIPS sales to TIPS Members. However, all purchase documents must include: (1) Authorized Reseller's Name; (2) Vendor's Name, as known to TIPS, and; (3) Vendor's TIPS Contract Name and Number under which it is making the TIPS Sale. Either Vendor or Reseller may report the sale pursuant to the terms herein. However, Vendor agrees that it is legally responsible for all reporting and fee payment as described herein for TIPS Sales made by Authorized Resellers. The TIPS Administration Fee is assessed on the amount paid by the TIPS Member, not on the Vendor's cost or on the amount for which the Vendor sold the item to a dealer or Authorized Reseller. The Parties intend that Vendor shall be responsible and liable for TIPS Sales made by Vendor's Authorized Resellers. Vendor agrees that it is voluntarily authorizing this Authorized Reseller and in doing so, Vendor agrees that it is doing so at its own risk and agrees to protect, indemnify, and hold TIPS harmless in accordance with Sections 14-17 above related to Authorized Reseller TIPS Sales made pursuant to this Agreement or purporting to be made pursuant to this Agreement that may be asserted against Vendor whether rightfully brought or otherwise. The Parties further agree that it is no defense to Vendor's breach of this Agreement that an Authorized Reseller caused Vendor of breach this Agreement.
- 20. Circumvention of TIPS Sales.** When a public entity initiates a purchase with Vendor, if the Member inquires verbally or in writing whether Vendor holds a TIPS Contract, it is the duty of the Vendor to verify whether the Member is seeking a TIPS purchase. Any request for quote, customer communication, or customer purchase initiated through or referencing a TIPS Contract shall be completed through TIPS pursuant to this Agreement. Any encouragement or participation by Vendor in circumventing a TIPS sale being completed may result in immediate termination of Vendor's TIPS Contract(s) for cause as well as preclusion from future TIPS opportunities at TIPS sole discretion.
- 21. State of Texas Franchise Tax.** By signature hereon, Vendor hereby certifies that Vendor is not currently delinquent in the payment of any franchise taxes owed to the State of Texas under Chapter 171 of the Texas Tax Code.
- 22. Termination.**
- A) Termination for Convenience. TIPS may, by written notice to Vendor, terminate this Agreement for convenience, in whole or in part, at any time by giving thirty (30) days' written notice to Vendor of such termination, and specifying the effective date thereof.
 - B) Termination for Cause. If Vendor fails to materially perform pursuant to the terms of this Agreement, TIPS shall provide written notice to Vendor specifying the default. If Vendor does not cure such default within thirty (30) days, TIPS may terminate this Agreement, in whole or in part, for cause. If TIPS terminates this Agreement for cause, and it is later determined that the termination for cause was wrongful, the termination shall automatically be converted to and treated as a termination for convenience.
 - C) Vendor's Termination. If TIPS fails to materially perform pursuant to the terms of this Agreement, Vendor shall provide written notice to TIPS specifying the default ("Notice of Default"). If TIPS does not cure such default within thirty (30) days, Vendor may terminate this Agreement, in whole or in part, for cause. If Vendor terminates this Agreement for cause, and it is later determined that the termination for cause was wrongful, the termination shall automatically be converted to and treated as a termination for convenience.
 - D) Upon termination, all TIPS Sale orders previously accepted by Vendor shall be fulfilled and Vendor shall be paid for all TIPS Sales executed pursuant to the applicable terms. All TIPS Sale orders presented to Vendor but not fulfilled by Vendor, prior to the actual termination of this agreement shall be honored at the option of the TIPS Member. TIPS shall submit to Vendor an invoice for any outstanding TIPS Administration Fees and approved expenses and Vendor shall pay such fees and expenses within 30 calendar days of receipt of such valid TIPS invoice. Vendor acknowledges and agrees that continued participation in TIPS is subject to TIPS' sole discretion and that any Vendor may be removed from the TIPS program at any time with or without cause. This

termination clause does not affect TIPS Sales Supplemental Agreements pursuant to this term regarding termination and the Survival Clause term.

- E) Vendor hereby waives any and all claims for damages, including, but not limited, to consequential damages or lost profits, that might arise from TIPS' act of terminating this Agreement.

- 23. Survival Clause.** It is the intent of the Parties that this Agreement and procurement method applies to any TIPS Sale made during the life of this Agreement even if made on or near the Contract Expiration Date as defined herein. - 25. Conflicts of Interest.** The Parties confirm that they have not offered, given, or accepted, nor intend to give at any time hereafter any economic opportunity, future employment, gift, loan, gratuity, special discount, trip, favor, service to the other in connection with this Agreement. Vendor affirms that, to the best of Vendor's knowledge, this Agreement has been arrived at independently, and is awarded without collusion with anyone to obtain information or gain any favoritism that would in any way limit competition or give an unfair advantage over other vendors in the award of this Agreement. Vendor agrees that it has disclosed any necessary affiliations with Region 8 Education Service Center and the TIPS Department, if any, through the Conflict of Interest attachment provided in the solicitation resulting in this Agreement.
- 26. Volume of TIPS Sales.** Nothing in this Agreement or any TIPS communication may be construed as a guarantee that TIPS or TIPS Members will submit any TIPS orders to Vendor at any time.
- 27. Compliance with the Law.** The Parties agree to comply fully with all applicable federal, state, and local statutes, ordinances, rules, and regulations applicable to their entity in connection with the programs contemplated under this Agreement.
- 28. Severability.** If any term(s) or provision(s) of this Agreement are held by a court of competent jurisdiction to be invalid, void, or unenforceable, then such term(s) or provision(s) shall be deemed restated to reflect the original intention of the Parties as nearly as possible in accordance with applicable law and the remainder of this Agreement, and the remainder of the provisions of this Agreement shall remain in full force and effect and shall in no way be affected, impaired or invalidated, unless such holding causes the obligations of the Parties hereto to be impossible to perform or shall render the terms of this Agreement to be inconsistent with the intent of the Parties hereto.
- 29. Force Majeure.** If by reason of Force Majeure, either party hereto shall be rendered unable wholly or in part to carry out its obligations under this Agreement through no fault of its own then such party shall give notice and full particulars of Force Majeure in writing to the other party within a reasonable time after occurrence of the event or cause relied upon. Upon delivering such notice, the obligation of the affected party, so far as it is affected by such Force Majeure as described, shall be suspended during the continuance of the inability then claimed but for no longer period, and such party shall endeavor to remove or overcome such inability with all reasonable dispatch. In the event that Vendor's obligations are suspended by reason of Force Majeure, all TIPS Sales accepted prior to the Force Majeure event shall be the legal responsibility of Vendor and the terms of the TIPS Sale Supplemental Agreement shall control Vendor's failure to fulfill for a Force Majeure event.
- 30. remedies, or immunities available to Region 8 Education Service Center or its TIPS Department under this Agreement or under applicable law shall not constitute a waiver of such privileges, rights, defenses, remedies, or immunities or be considered as a basis for estoppel.

- 31. Insurance Requirements.** Vendor agrees to maintain the following minimum insurance requirements for the duration of this Agreement. All policies held by Vendor to adhere to this term shall be written by a carrier with a financial size category of VII and at least a rating of "A-" by A.M. Best Key Rating Guide. The coverages and limits are to be considered minimum requirements and in no way limit the liability of the Vendor(s). Any immunity available to TIPS or TIPS Members shall not be used as a defense by the contractor's insurance policy. - 37. Assignment.** No assignment of this Agreement or of any duty or obligation of performance hereunder, shall be made in whole or in part by a Party hereto without the prior written consent of the other Party. Written consent of TIPS shall not be unreasonably withheld.
- 38. Minimum Condition and Warranty Requirements for TIPS Sales.** All goods quoted or sold through a TIPS Sale shall be new unless clearly stated otherwise in writing. All new goods and services shall include the applicable manufacturers minimum standard warranty unless otherwise agreed to in the Supplemental Agreement.

- 41. Vendor shall remain fully informed of and in compliance with all ordinances and regulations pertaining to the lawful provision of goods or services under the TIPS Agreement. TIPS and TIPS Members reserve the right to stop work and/or cancel a TIPS Sale or terminate this or any TIPS Sale Supplemental Agreement involving Vendor if Vendor's license(s) required to perform under this Agreement or under the specific TIPS Sale have expired, lapsed, are suspended or terminated subject to a 30-day cure period unless prohibited by applicable statute or regulation.



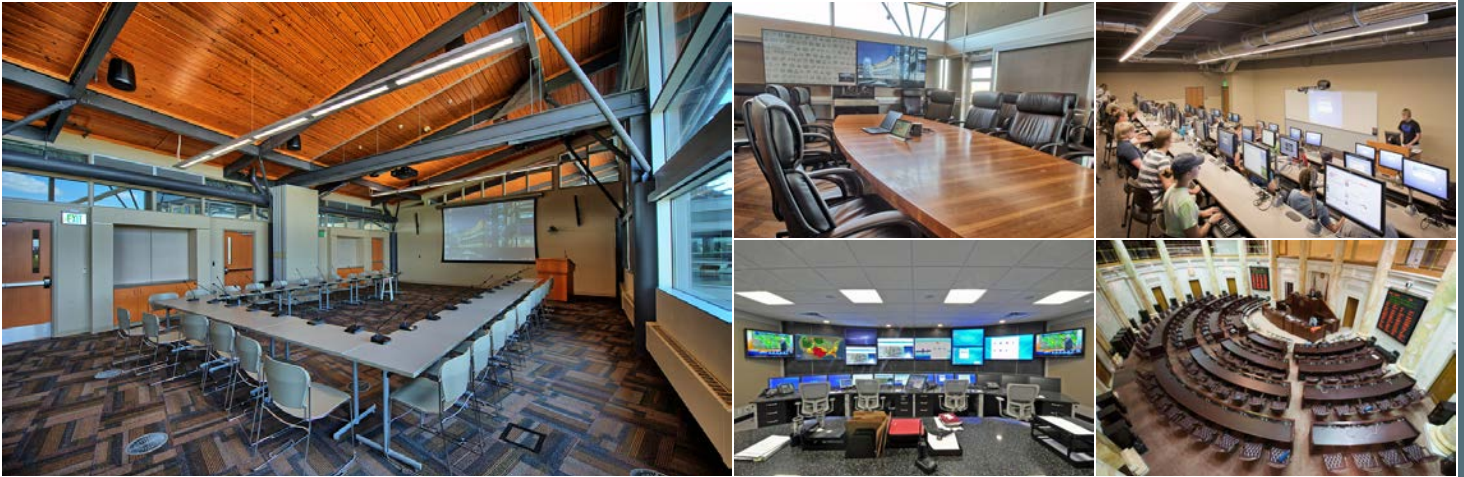

The Prototype

In the 1920s, J. Scottie Stanley founded Stanley Sound Systems. In its earliest days, the company led Arkansas into the golden age of radio, sound systems, and a new invention: talking motion pictures. As new audio and video technologies were introduced, Stanley Sound was the first to introduce them to the people and organizations of Arkansas.

Public address systems, both portable and installed, were a core offering of Stanley Sound during the early days and would remain so for its duration. Among the first customers for installed PA systems were churches and the company's portable systems were used in such places as Ray Winder Field and, perhaps more interestingly, were mounted to cars emblazoned with the Stanley Sound Systems logo. These vehicle-mounted systems were a popular method of mobile advertising during election seasons and greatly simplified set up and take down for short-term events like sports.

The company was involved in early radio technology not just for commercial broadcasting, but also for law enforcement and military installations. Shortwave radio communications systems by Stanley Sound were integral in the coordination of the activities of up to 14,000 workers at the Arkansas Ordnance Plant. Established in 1942 near Jacksonville, the plant produced more than one billion detonators and relays along with hundreds of millions of primers, percussion elements, fuses, and boosters in support of the war effort during its 3-years.

Stanley Sound Systems' endeavors were hardly limited to sound technology. The company provided 16mm and 35mm motion picture projectors as well. Among the earliest clients were traveling tent shows which had begun transitioning from Vaudeville and Wild West shows to moving picture shows during the early 20th century. As these tent shows declined during the great depression, the company began providing film projector technology to the first public theaters.

Opaque projectors and magic lanterns were other popular display devices. These predecessors to document cameras and slide projectors were powerful tools for clients in business and education. Stanley Sound Systems continuously cultivated its position as Arkansas' provider of anything related to sight, sound, and information.



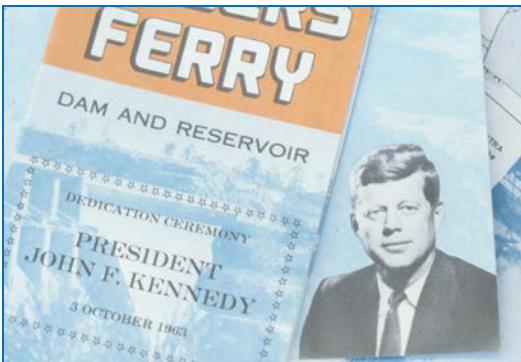


"Mid-Century Modern"

In 1958, the National Defense Education Act was passed. In addition to promoting science education as a defense against communism, the act promoted foreign language skills and education technology. The most popular language instruction method at that time was the Army Method which relied heavily on oral drills in which students repeated words and phrases from audio recordings while their own voices were recorded onto tapes for review. Stanley Sound Systems, having introduced audio recording systems to Arkansas only years earlier, was well positioned to provide this new technology and completed language labs across the state.



Stanley Sound marked another milestone in 1958 when Jay Stanley began working full time with his father. Having shadowed his father for more than a decade in his childhood and adolescence, Jay hit the ground running. The company expanded its rental offerings and continued to look for exciting new products to serve its growing client base. To simplify ever more complex presentation technology, the company began crafting custom control systems. These push button boxes centralized operation of multiple projectors, recorders, and playback devices.



The company also stayed on the cutting edge of recording technology. In the mid-1960s Stanley Sound Systems began offering video recording devices. These early video tape recorders (VTRs) used magnetic tape technology which meant that film no longer had to be developed before recorded video could be played back. Although they were marketed as consumer models, they were more popular in the corporate

and education communities. The starting price for these devices in the mid-1960s was around \$700: more than 10% of the average family's annual income and more than \$5,000 in today's dollars.

The company's reputation was unmatched in Arkansas. The Stanley Sound name was synonymous with information technology and innovation. In 1963, the company was called on to provide audio services at the dedication of the Greers Ferry Dam where President Kennedy delivered remarks in his last major public address. The company also provided systems atop Petit Jean Mountain for Winthrop Rockefeller and the charitable organizations that he formed.

In 1969, Stanley Sound played a major role in the Republican Governors Association's Semi-Annual conference held at the Arlington Hotel in Hot Springs. The high-profile event was attended by such notables as Spiro Agnew, Winthrop & Nelson Rockefeller, Ronald Reagan, and a slew of figures who would go on to serve in the U.S. Senate, House of Representatives, and the administrations of Presidents Nixon, Ford, and Reagan.



In 1972, after developing a chronic illness, Scottie Stanley sold Stanley Sound Systems to Joe Carlton, co-founder of the multi-million dollar Carlton-Bates Company. Scottie and Jay continued to work for the company under its new name, Stanley Communications. Around this time, a young J. Scott Stanley would begin to tag along with his father and grandfather as they installed church sound systems and intercom systems. Along with learning to install, repair, and service audiovisual equipment, Scott would develop a life-long passion for sound, video, and associated technologies.



A New Start

Jay left Stanley Communications a few years after it was sold so he could work in industrial systems and product sales. During this time he continued to be involved in audiovisual technology, working in the field during his time away from his sales job. In 1978, he returned to presentation technology full time when he incorporated Jay S. Stanley & Associates.

Scott's professional career began in 1980 when he began working at Arkansas Sound. Not yet 20, Scott was already an expert in many aspects of the audiovisual industry. During his 2-years at Arkansas Sound, Scott began to develop his expertise in acoustics. He practically memorized *Sound System Engineering*, a seminal book by Don & Carolyn Davis that changed the field of audio engineering. After attending a Syn-Aud-Con seminar taught by Mr. Davis, Scott's devotion to physics and acoustics was steadfast. His enthusiasm was infectious and before long several of his friends had joined him in the industry.

In 1982, Scott joined his father at Jay S. Stanley & Associates. Our early work included many of the services provided by Stanley Sound Systems years earlier: sound reinforcement systems, remote control, and slide and overhead projector systems. Similarly, many of the first systems were installed in sanctuaries, chapels, and other worship spaces: the same places Jay had worked (and Scott had tagged along) years before with Stanley Sound Systems.



In the mid-1980s, we began to expand our focus to include microprocessor-based remote control systems, computer graphics, and consulting & design services for building owners and architects. By the end of the decade, audiovisual control systems had become much more powerful and touch screen technology was introduced. This new control technology allowed significant simplification and automation of audio, video, film, and environmental control and created a new niche that has remained at our core to this day. In the meantime, our projector and display technology evolved from film to cathode ray tubes (CRTs). Our work took us into boardrooms, classrooms, and training facilities. We continued to work with many of Arkansas' most well-known and respected institutions, organizations, and agencies.

State of the Art

Our technology services and products pushed us into new markets during the 1990s. We continued to put the most innovative technology at the core of our service offerings. We became one of the first companies in Arkansas to offer videoconference technology which had quickly matured due to improvements in public and private network capacity, compression technology, and standardization.



Our work with videoconference technology took us into new spaces such as distance learning facilities and videoconference rooms. Computer graphics and display technologies continued to evolve and the advent of LCD projectors again expanded our customer base in the corporate, medical, government and higher education spheres.

We are proud to say that many of our earliest systems are still in use. We have developed hundreds of customer relationships; many of them going back to our earliest years. We continue to be Arkansas' leader in innovative and reliable audiovisual technology. Today, our systems include the latest advancements such as cloud technology, digital signal processing, and interactive displays. Our goal continues to be the same as it has been since our first day: provide the highest levels of reliability and customer satisfaction by integrating comprehensive solutions that connect presenters with audiences.

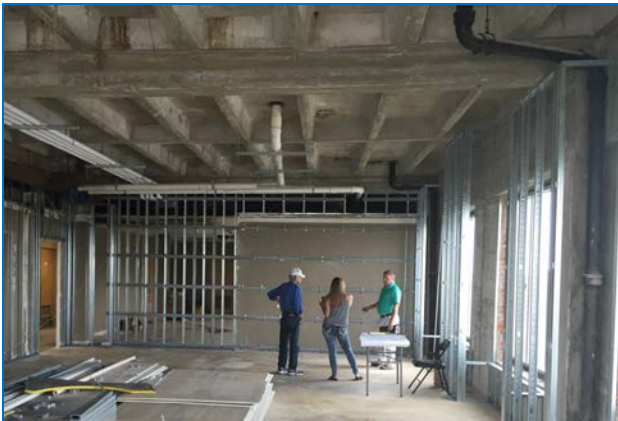

Training & Certification





Project management is on-going: it begins during the design process and continues beyond the warranty period. We coordinate with stakeholders both internally and externally. External stakeholders may include owners, contractors, architects, and employees thereof.

We maintain many records which include e-mails, photos, documents (internally- and externally-produced), and more. These records allow us to achieve high levels of efficiency and to coordinate effectively.

The type of management we carry out varies depending on whether the project is new construction, renovation, or a completed building. A few of the tasks that we complete are listed below.

- Conduct regular job site visits.
- Attend project meetings with architects, contractors, owners, and others.
- Monitor the progression of construction or renovation.
- Ensure completion of audiovisual system prerequisites such as placement of floor boxes and infrastructure that is installed by other trades (most commonly electrical contractors).
- Keep up-to-date with deadlines and completion goals.





During fabrication, we assemble system components in-house and begin preparing for on-site installation. All system components are shipped to our shop rather than to the job site. This keeps high tech equipment secure and also allows us to maintain high levels of efficiency and preparation.

We complete every task possible while the system is still in our workshop. Doing this allows us to spend less time on-site which helps you achieve project milestones on time. Some of the tasks that we complete during fabrication are listed below.

- **Assemble Furniture:** Some furniture comes fully-assembled, but most pieces comes ready-to-assemble.
- **Install Equipment:** Equipment is installed in lecterns, racks, or other furniture.
- **Wire Systems:** Individual components are wired together so they can work as a system.
- **Prepare for On-Site Installation:** We complete as much as possible before taking equipment on-site.



During the software phase, we set up every component (including devices that won't be installed until they reach the job site). The system is configured to control projectors, playback devices, screens, lighting, and many other components.

Control system hardware will not operate without the development of control software. This hardware arrives from the manufacturer like a computer with no operating system (e.g.: Microsoft Windows). A programmer must load code into the hardware before it will connect to system components like media players or a touch panel. Every firm has a different approach to control system software and the technique that is used can have a major impact on how simply and reliably your system works.

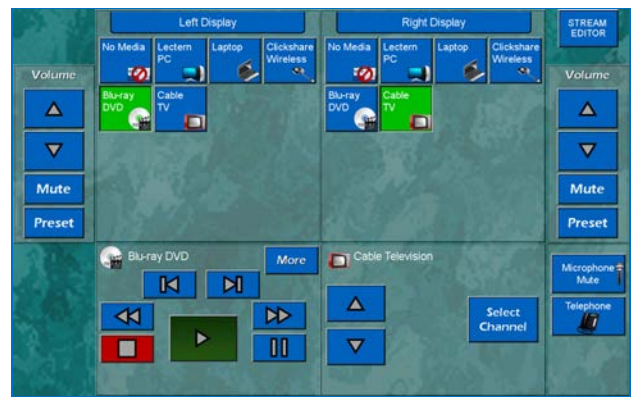
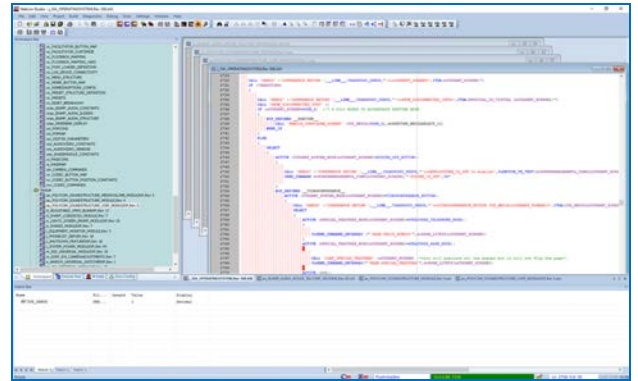
As the system is configured at our facility, components are being tested at one of several quality control checkpoints. We look for compatibility issues, hardware defects, and other problems during this phase. When we find issues in our workshop, we can fix them before they reach the field.

Control systems for complex projects and environments are one of our core competencies. We coordinate control of all the devices in a system to greatly simplify operation. Independent equipment is unified to work like a single component. With the push of a button, screens come down automatically, projectors turn on, a lighting preset is called to dim the fixtures near the screen, the AV receiver is automatically switched to the correct input, and a volume preset is loaded.

System standardization is key to our reliability. Each of our control systems works the same way. As we implement refinements, they are carried through to subsequent systems. When we identify issues with a component in our standard collection, it is simple for us to "roll out" fixes to other systems that use the same devices.

In addition to improving reliability, our standardized systems cut the learning curve for repeat clients. New systems operate nearly identically to systems installed 10 or 20 years before. Once a user understands how to operate one of our systems, he or she can easily operate another in a different room, different building, or different city.

We began using AMX controls in 1988 and now use their control system hardware exclusively. We've developed strong relationships with AMX's employees and this helps us achieve timely solutions when we encounter problems we cannot solve ourselves. Our in-depth knowledge of their products and technologies is unparalleled in Arkansas.





Installation begins with wall plates, speakers, and other "field" components. While a building project is in the rough phase, we install cables and mechanical equipment in preparation for the products to follow.

Additional materials are installed as the project progresses through subsequent stages.

By the time the main system components arrive on site, field equipment is installed and prepped. Once all system components have been delivered to the job site, a technician integrated the field components.



Once installation is substantially complete, technicians will conduct preliminary quality control. The basic functions of the system will be run through and all field components will be tested.

Since the system has already been set up and tested in our workshop, the technician knows that issues discovered at this quality control checkpoint are likely to be in field cabling or field components. This allows them to diagnose issues efficiently.



Quality control is followed throughout our system integration processes.

We set up every system in our facility prior to delivery. This allows us to apply important updates and find defective hardware before it leaves our building.

We all know that testing in a laboratory setting sometimes differs from the real world. When installation is completed, technicians meticulously re-test the control software and all hardware for any operational inconsistencies.

In more complex systems, quality control may require several sequenced steps to refine and verify all operational scenarios.

Also during quality control, we perform any calibration that is required. Audio levels are optimized to each room environment based on individual characteristics. Lighting presets are refined to provide the best viewing conditions for projected images.

When quality control is approved, a technician certifies the system is complete and end-users receive training.

When your system is powered on (p. 5), you will be presented with the Main Page. This page is broken into four portions which are described below.

A Sources Menu

Each audio and video source that is a part of your system has an associated button on this menu. To view or listen to one of the sources, touch the corresponding button. The active source button will have a green background.

When a source other than No Media (p. 16) is selected, a series of automated operations will begin. These operations may include turning on the projector, lowering the electric projection screen and projector lift, and setting preset levels for audio.

Above the media sources, the Projection Screen and Projector button (p. 9) provides access to manual control of your projector lift and electric screen.

B Source Transports

When a media source is selected, this area will display buttons for controlling the active source.

When you select a playback source like DirecTV, this area will display transport buttons such as guide, menu, and channel up/down. Input sources

Training is scheduled for a date and time that will allow as many end-users as possible to attend. We recommend that you include anyone that could possibly use the system in the training session. During training, our trainer will go over every function of the system from control system operation to connecting microphones, lecterns, and auxiliary devices. You will be presented with operations manuals for the system and for individual components along with other documents such as serial number lists.

When you must use your system prior to the formal training session, one of our technicians can provide a quick rundown of the system. Often this can be done over the phone or in-person after final quality control. Using your system prior to formal training provides an opportunity for users to identify areas they do not fully understand so that clarification can be provided during the training session.



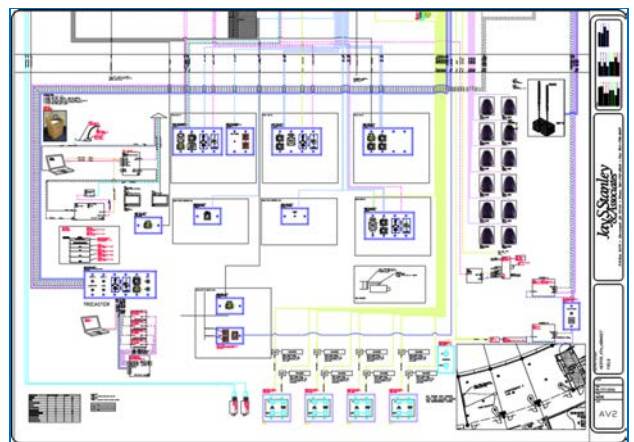
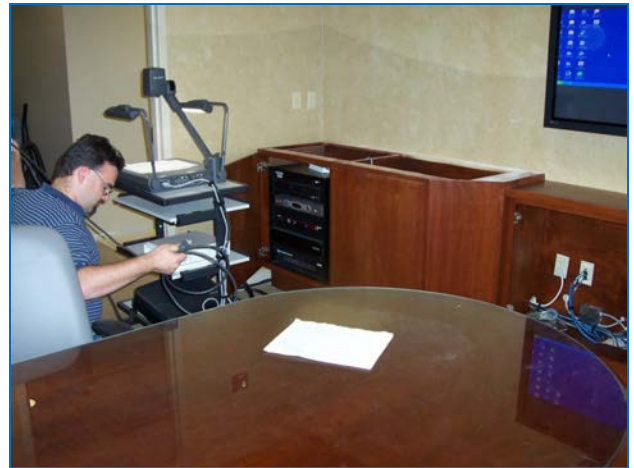

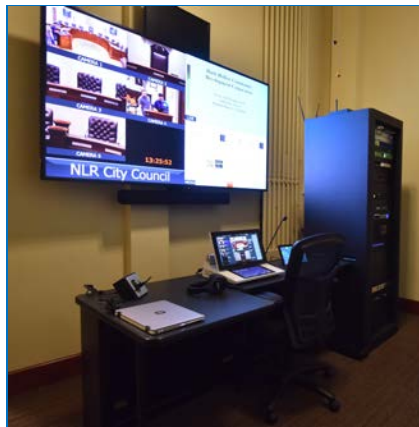

City of North Little Rock, AR

North Little Rock City Hall was constructed in 1914-15, and was listed on the National Register of Historic Places in 1975.

In 2005, the building and council chambers underwent renovations which restored portions to their original state along with various other enhancements and updates.

- Four pan-tilt-zoom cameras send video to a control room from which it can be streamed over the internet and transmitted to public television networks.
- Microphones at each council member's seat are activated by push button and also controlled from the touch panel at the mayor's seat.
- Multimedia content is projected onto screens on the right and left walls of the chamber.

- A conference discussion system consists of request-to-speak microphones at each seat.
- Multimedia content is projected on the screen at the front of the chamber and also displayed on monitors at each director's seat.
- Special fixtures provide studio-quality lighting.
- Video can be streamed over the internet and transmitted to public television networks.

Little Rock City Hall is located on the northwestern corner of West Markham and Broadway. Designed by noted architect Charles L. Thompson, it has been the seat of city government since 1908.

The capital city of Arkansas is also the state's largest municipality, with nearly 200,000 people calling it home. The City of Little Rock employs approximately 2,500 employees in 14 departments.

City of Maumelle, AR

Renovations of Maumelle's City Hall began in late 2019 and, in early 2020, JSA was engaged to help with planning and budgeting.

The project, which included conference rooms and the lobby in addition the council chamber, facilitated in-person meetings plus recording, streaming, and conferencing.

Equipment from the previous systems (by others) was incorporated in the new systems.

- The integrated touch control system provides management of the Beyerdynamic Orbis microphone system including request-to-speak queue and chairperson override.
- The touch interface also incorporates control of the PTZ (pan-tilt-zoom) cameras, multimedia playback, telephone conferencing, streaming/recording functions, and more.

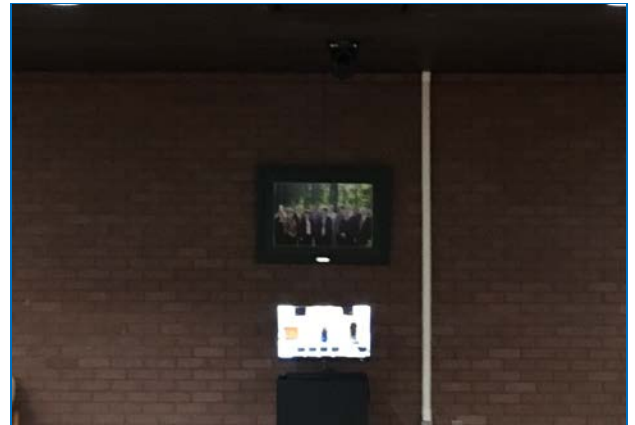

- The streamer/recorder is managed from its browser-based interface using networked devices and also from the rack location using the connected monitor, mouse, and keyboard.
- PTZ (pan-tilt-zoom) camera operation is provided by the handheld remote control.
- Manually operated Beyerdynamic Orbis microphone system includes 11 stations and can be configured for push-to-speak, request-to-speak, and first-in/first-out.

The original system installed by JSA in 2000 had been upgraded several times by the customer and by other firms.

In 2019, JSA was engaged to improve the performance of the audio system and consumer-grade streaming system.

The existing systems were reconfigured and upgraded with recorder/streamer, PTZ (pan-tilt-zoom) camera, and manual controls.

State of Arkansas

Legislative committees meet in the four committee rooms in the state capitol. These rooms are among the most used legislative meeting spaces.

As part of restoration projects in the capitol, the committee rooms began renovations in 2016. In addition to restoring the rooms and furnishings to their original appearance, the work included enhancements to the functionality of the rooms.

- A conference discussion system consists of push-to-speak microphones at each seat. From the chairperson's position, microphones can be muted.
- Computer video inputs at each end of the table provide multimedia presentation capabilities.
- Pan-Tilt-Zoom cameras transmit video to the control booth near the house chamber where it is streamed over the internet and broadcast over public television networks.

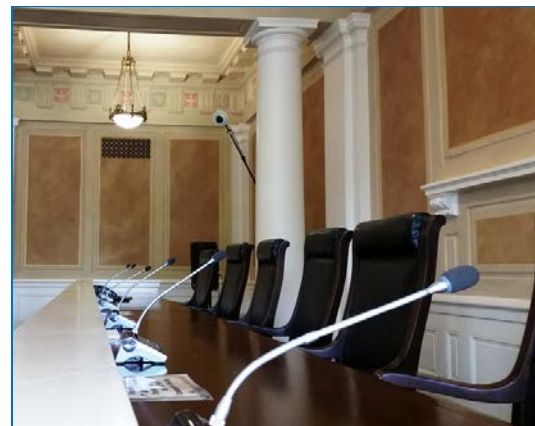

The Arkansas Supreme Court met in this chamber from 1912 through 1958 when it moved to the Justice Building. The chamber is now used for ceremonies, meetings, lectures, and private events.

In 2000, the chamber was restored to its 1912 appearance. Many of the furnishings are originals from 1912 while others have been recreated to match the originals.

- A wireless conference discussion system consists of 12 microphones and accessories which can be stored away when not needed.
- Low-profile speakers are barely noticeable which helps visitors focus on the ornate room and its historical significance.

This room in the multi-agency complex on the capitol mall is used for joint committee meetings attended by members of both the House of Representatives and Senate.

A special feature tracks the different seating positions of members of each committee and presents their names to the chairperson as they request the floor.



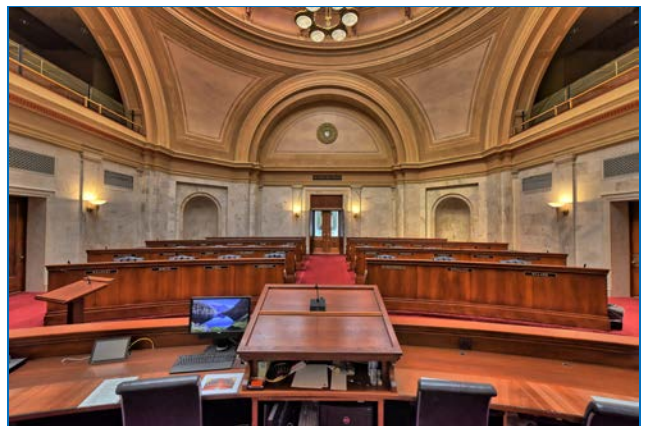

The building was listed on the U.S. National Register of Historic Places in 1974 and has undergone renovations several times during its 100+ years.

- Cameras in the chamber and committee rooms display members during addresses.
- From the control booth, video can be recorded and streamed over the internet and television networks.
- Zoom Rooms video meetings can take place from the chamber and committee rooms.
- Switching matrix allows video and audio to be routed to and from committee rooms and chamber for overflow and to create a video call without using the internet.



Arkansas Electric Cooperative Corporation

- Rear projection system enables multimedia presentations.
- A conference discussion system consists of push-to-speak microphones at each seat.
- Four pan-tilt-zoom cameras allow video to be recorded and live streamed.
- The cameras also support video conferencing capabilities and automatically focus onto activated microphone locations.

AECC was created on July 11, 1949 to provide Arkansas' electric cooperatives with a reliable and affordable power supply. Based in Little Rock, it is one of the top generation and transmission cooperatives in the nation.

AECC and Arkansas Electric Cooperatives, Inc. (AECI), along with the state's 17 electric distribution cooperatives, are known collectively as the Electric Cooperatives of Arkansas.



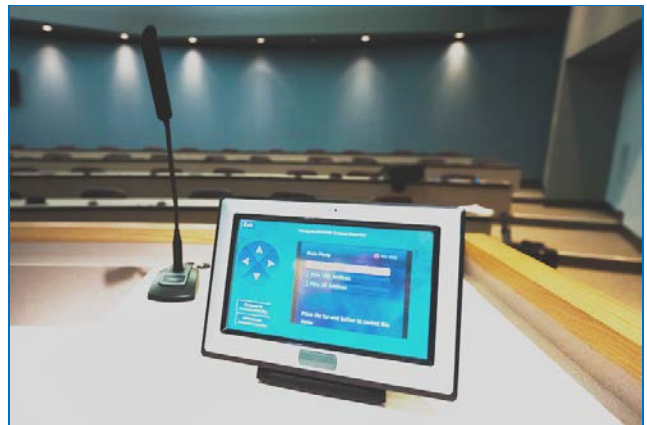

Little Rock School District

The district has an enrollment of more than 25,000 students and around 3,800 employees. It has 5 high schools, 7 middle schools, 29 elementary schools, 4 early childhood centers, 2 alternative schools, 1 adult education center, 1 accelerated learning center, and 1 career-technical center.

The technology center provides professional development for faculty and staff via distance learning and in-person training.

- Cameras mounted on the front wall, rear wall, and a portable stand facilitate a number of options for video conferencing.
- Microphones at each seat allow participants to interact with far site instructors and one another.
- The front camera automatically positions onto the active microphone location.
- From the integrated lectern, a presenter can control multimedia and video conferencing functions.



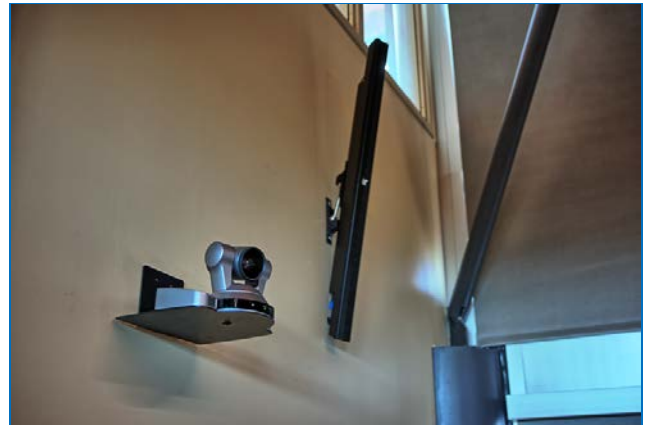

- A monitor above the rear camera shows the same content as the front so presenters do not have to turn away from the audience.



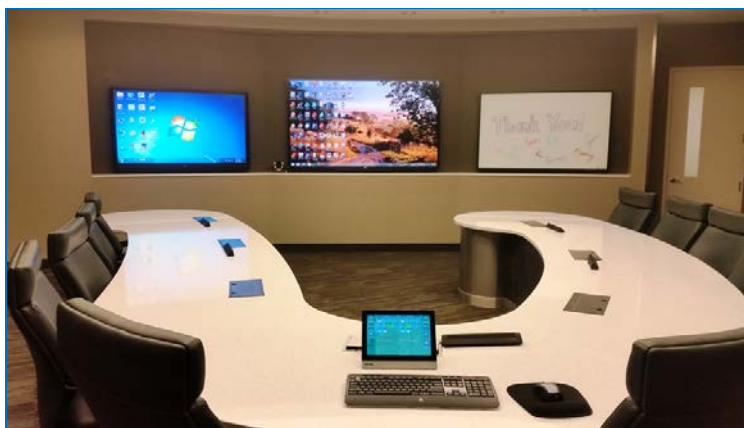
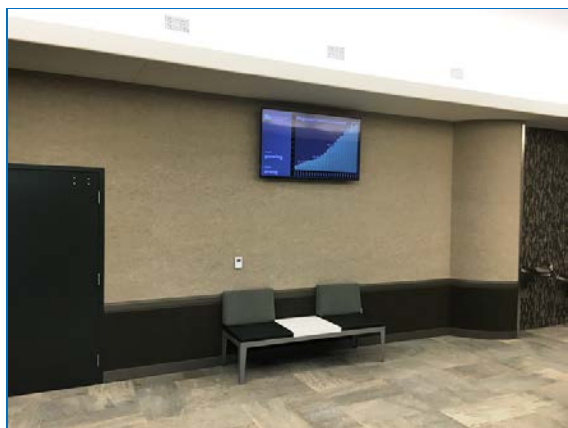
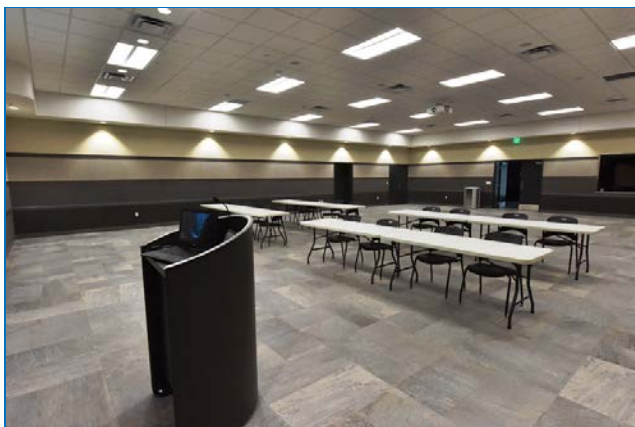

- Next to the center screen, a small PTZ camera facilitates video conferences.

This community room is offered for public use free of charge. There are tables, chairs, and kitchen facilities available in each room. Any non-profit group or individual may use the room for events.



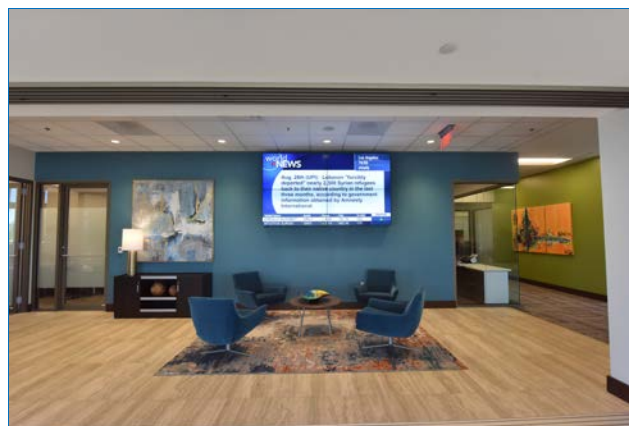
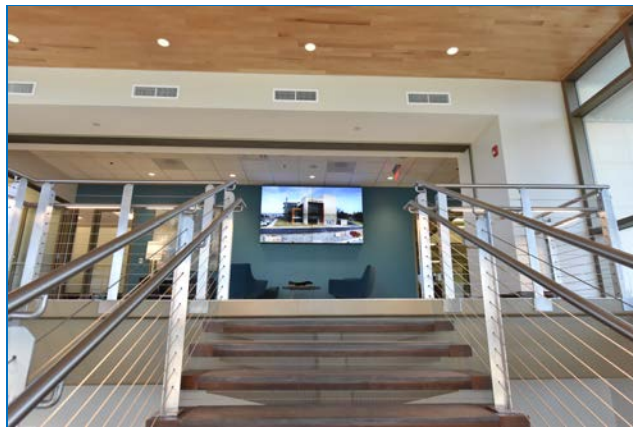

Citizens Bank Headquarters

Citizens Bank was established in Batesville, Arkansas, in 1953 by a group of local business leaders who shared a vision of creating a bank that would be committed to serving working people.

Citizens Bank is owned by local shareholders and governed by a local Board of Directors, most of whom live, work and invest alongside customers.

- Each 2x2 video wall consists of four 55-inch LCD displays featuring narrow bezels and a combined 4K resolution.
- First floor video wall welcomes visitors as they enter the building. Video wall on the second floor shortens perceived wait times.
- Displays connect to customer's signage system to provide information about products and services and also connect to the building's television system.



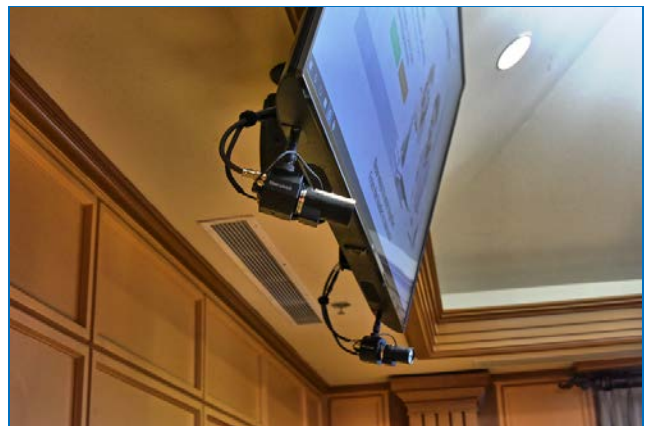

- Monitors positioned around the table make it simple for every justice to take part in video conferences and to view materials that are being presented.
- Fixed cameras facilitate video conferencing.

The Arkansas Supreme Court Justice Building was dedicated in 1958. In 1976 the circular courtroom annex was constructed. It is used by the Supreme Court and Court of Appeals for hearings, weekly oral arguments and swearing-in ceremonies.

The conference room is part of the west wing of the building which was dedicated in 2001. It is part of a secure zone which also includes seven suites for each Justice.

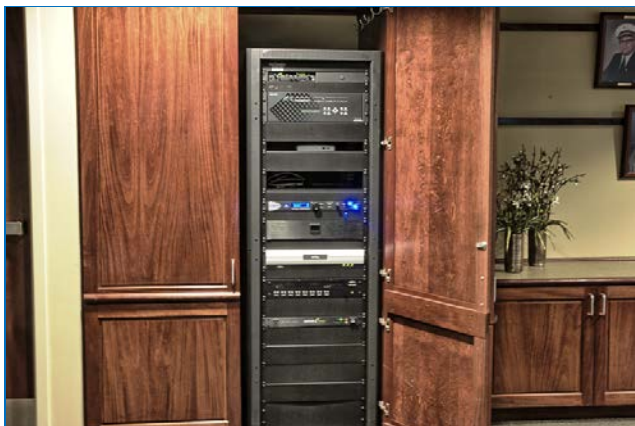

A purpose for LOPFI is to maintain a financially sound retirement system so that each covered police officer and firefighter will receive the full value of their earned benefit for their lifetime.

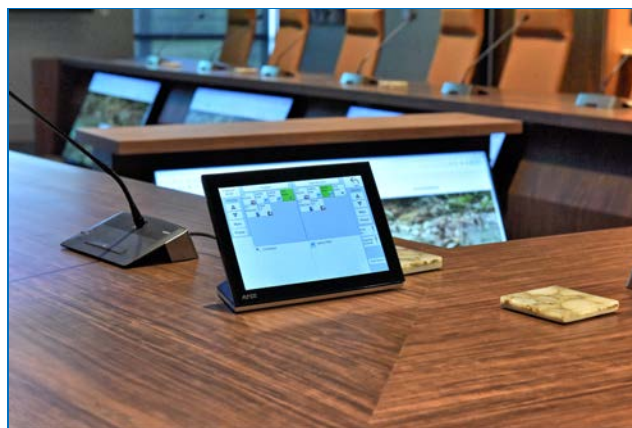
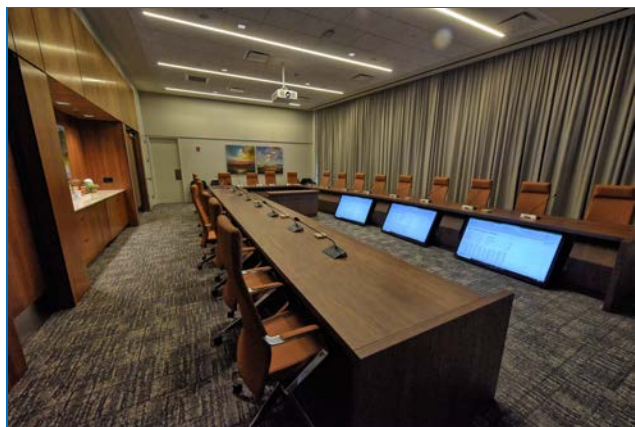

- Presenters can address the audience from the lectern on stage and a mixing console in the balcony facilitates live musical performances.



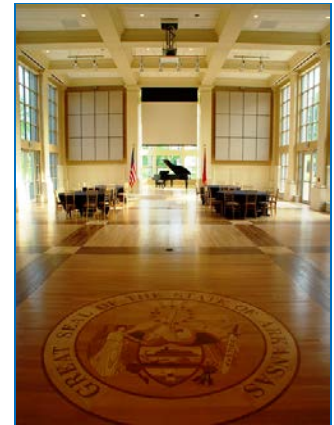
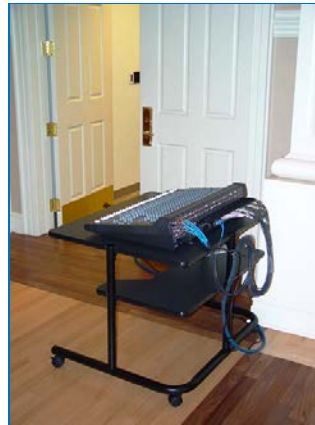

- The system is both a full presentation system and a musical performance system depending on the configuration that is selected on the touch panel.
- An electric lift keeps the projector out of sight when it is not needed.
- Large baffles at the front of the room provide aesthetic value in addition to concealing the high-quality speaker system and enhancing room acoustics.

The Arkansas Governor's Mansion, located on Center Street in the historic Quapaw District of downtown Little Rock, was completed in January 1950. The Grand Hall and connecting glass atrium opened in the spring of 2003.

The addition of the Grand Hall allowed for entertaining larger groups of people, as it can comfortably seat up to 220 people for a luncheon or dinner.

- Stage microphones and monitor speakers connect via floor boxes in the stage.

Arkansas Department of Parks & Tourism

Arkansas's largest state park in land area, Hobbs State Park-Conservation Area (HSPCA) covers a 12,056-acre tract of diverse Ozark landscape along the southern shore of 28,370-acre Beaver Lake.

The park's 17,531-square-foot visitor center opened in 2009. This state-of-the-art facility features Ozark focused exhibits including interactive kiosks, classroom space, a retail sales area, and the park's administrative offices.

- The classroom is a multi-use space featuring presentation lectern, ceiling speakers, and integrated projection system.
- The small orientation room shows an introductory video on a regular, user-definable schedule and also accomodates presentations by a park interpreter.
- In the exhibition area, a sound reinforcement system plays user-selectable audio such as wildlife sounds on demand.



Arkansas Game & Fish Commission

- Touch panels at exhibits provide interactivity for visitors and allow them to gain a deeper understanding of the AGFC mission.
- A multi-purpose room shows an introductory video on a regular, user-definable schedule and also accomodates presentations.

The center focuses on the outdoor opportunities that our state's wildlife resources provide. Exhibits highlight the role of fish and wildlife management along with projects conducted throughout the history of the Game and Fish Commission.

The grounds of the center include plants native to the state, while the main building includes an exhibit hall, aquariums, gift shop, theater, and spaces for educational programs.
