



HERE'S WHAT HAPPENED

In May 2020, San Angelo, Texas was the center of a 4-5" hailstorm that damaged everything in its path. The damage to the YMCA was so severe that the hail broke through the PVC roofing membrane and the insulation board beneath.

As a result, the entire interior of the building was flooded due to no protection from the roofing system. This was a catastrophic loss to the building and the community.
