TIPS VENDOR AGREEMENT

Between Ion Wave Technologies, Inc. ("Vendor")

and

THE INTERLOCAL PURCHASING SYSTEM (TIPS),

a Department of Texas Education Service Center Region 8 for TIPS RFP 210101 Technology Solutions, Products and Services

General Information

The Vendor Agreement ("Agreement") made and entered into by and between The Interlocal Purchasing System (hereinafter "TIPS") a government cooperative purchasing program authorized by the Region 8 Education Service Center, having its principal place of business at 4845 US Hwy 271 North, Pittsburg, Texas 75686 and Vendor, having its principal place of business at 3653 South Avenue, Springfield, Missouri 65807. This Agreement consists of the provisions set forth below, including provisions of all attachments referenced herein. In the event of a conflict between the provisions set forth below and those contained in any attachment, the provisions set forth shall control unless otherwise agreed by the parties in writing and by signature and date on the attachment.

A properly executed license agreement between the Vendor and TIPS Member is the TIPS Member's approval providing the authority to proceed with the negotiated software subscription and any related professional services under the Agreement. Special terms and conditions as agreed between the Vendor and TIPS Member will be added to the license agreement or as addendums to the license agreement by mutual consent between the Vendor and TIPS Member. The license agreement between the Vendor and the TIPS Member will govern the relationship between the Vendor and the TIPS Member.

Terms and Conditions

Warranty Conditions

The resulting license agreement between the Vendor and the TIPS Member will outline the warranties provided with the software subscription and any related professional services. Vendor will provide a warranty to the TIPS Member for the full term of the TIPS Member's license agreement.

Customer Support

The Vendor shall provide timely and accurate customer support to TIPS Members as provided for in the license agreement between the Vendor and TIPS Member. Vendors shall respond to such requests within a commercially reasonable time after receipt of the request. If support and/or training is a line item sold or packaged with a sale, support shall be as agreed with the TIPS Member.

Agreements

Vendor requires the TIPS Member to enter into a mutually acceptable license agreement, executed by the authorized agents for each party. This license agreement will govern the relationship between the Vendor and TIPS Member. Vendor shall not be required to comply with TIPS standard terms and conditions as included in the solicitation or Vendor Agreement to the extent excepted by the terms negotiated herein or governed by the vendor-required mutually acceptable license agreement between the Vendor and TIPS Member.

Tax exempt status

Most TIPS Members are tax exempt and the related laws and/or regulations of the controlling jurisdiction(s) of the TIPS Member shall apply. The license agreement between the Vendor and TIPS Member will include terms related to tax-exempt status.

Assignments of Agreements

No assignment of this Agreement may be made without the prior notification of TIPS. Written approval of TIPS shall not be unreasonably withheld. The license agreement between the Vendor and TIPS Member will include language governing any assignment as to the relationship between Vendor and the TIPS Member. Payment for delivered goods and services can only be made to the awarded Vendor, Vendor designated reseller or vendor assigned company.

Disclosures

- Vendor and TIPS affirm that he/she, or any authorized employees or agents, has not given, offered to
 give, nor intends to give at any time hereafter any economic opportunity, future employment, gift,
 loan, gratuity, special discount, trip, favor or service to a public servant in connection with this
 Agreement.
- Vendor shall attach, in writing, a complete description of any and all relationships that might be considered a conflict of interest in doing business with the TIPS program.
- The Vendor affirms that, to the best of his/her knowledge, the offer has been arrived at
 independently, and is submitted without collusion with anyone to obtain information or gain any
 favoritism that would in any way limit competition or give an unfair advantage over other vendors in
 the award of this Agreement.

Term of Agreement and Renewals

The Agreement with TIPS is for approximately five (5) years with an option for renewal for an additional one (1) consecutive year. If TIPS offers the renewal extension year, the Vendor will be notified by email to the primary contact of the awarded Vendor and shall be deemed accepted by the Vendor unless the awarded Vendor notifies TIPS of its objection to the additional term. TIPS may or may not exercise the available extension(s) provided in the original solicitation beyond the base five-year term. Whether or not to offer the extension is at the sole discretion of TIPS.

"Start Date" for Term Calculation Purposes Only: Regardless of actual award/effective date of Contract, for Agreement "term" calculation purposes only, the Agreement "start date" is the last day of the month that Award Notifications are anticipated as published in the Solicitation

Example: If the anticipated award date published in the Solicitation is May 22, but extended negotiations delay award until June 27, The end date of the resulting initial "five-year" term Agreement, (which is subject to an extension(s)) will still be May 31, 2025.

"Termination Date": The scheduled Agreement "termination date" shall be the last day of the month of the month of the Original Solicitation's Anticipated Award Date plus five years.

Example: If the original term is approximately five years, and the solicitation provides an anticipated award date of May 22, 2020, the expiration date of the original five-year term shall be May 31, 2025.

Extensions: Any extensions of the original term shall begin on the next day after the day the original term expires.

Example Following the Previous Example: If TIPS offers a one-year extension, the expiration of the extended term shall be May 31, 2026.

TIPS may offer to extend Vendor Agreements to the fullest extent the original Solicitation permits.

Automatic Renewal Clauses Incorporated in Awarded Vendor Agreements with TIPS Members Resulting from the Solicitation and with the Vendor Named in this Agreement.

Vendor agrees that it will enter into a mutually acceptable license agreement with all TIPS Members who wish to purchase Vendor's software and services. Any automatic renewal terms in the license agreement will be clearly stipulated in writing, including renewal pricing. TIPS Members will be responsible for ensuring that they are properly entering into an agreement based on their governing body's policies, including policies relating to appropriation and future budgets. Vendor will work with the TIPS Member to incorporate non-appropriation language into license agreement at the request of the TIPS Member. Vendor agrees that any automatic renewal as permitted by the terms of the mutually acceptable license agreement will be preceded by an invoice sent to the TIPS Member and the Member shall have thirty (30) days from the date of the invoice to opt out of the automatic renewal.

Shipments

In the event that Vendor will provide physical products or on-site services, Vendor shall ship, deliver or provide ordered products or services within a commercially reasonable time after the receipt of the order from the TIPS Member. If a delay in said delivery is anticipated, the Vendor shall notify TIPS Member as to why delivery is delayed and shall provide an estimated time for completion of the order. TIPS or the requesting entity may cancel the order if estimated delivery time is not acceptable or not as agreed by the parties.

Invoices

The TIPS Contract Number will be indicated in the mutually agreed license agreement between the TIPS Vendor and TIPS Member. Vendor will self-report to TIPS all payments received under license agreements entered into under Vendor's applicable TIPS contract. Vendor will invoice TIPS Members in accordance with the terms of the mutually agreed license agreement between the Vendor and the TIPS Member, which will include language related to invoicing processes.

Payments

TIPS Members will be required to make payments to Vendor in accordance with the terms of the mutually agreed license agreement between the Vendor and TIPS Member, which will include language related to payment processes.

Pricing

Price increases will be honored according to the terms of the solicitation. All pricing submitted to TIPS shall include the participation fee, as provided in the solicitation, to be remitted to TIPS by the Vendor will not show adding the fee to the invoice presented to TIPS Member customer.

Vendor shall not be required to comply with the Equal Pricing requirement as included in the solicitation (Terms and Conditions #6), but Vendor shall comply with the pricing submitted to TIPS (including any price changes made in accordance with the terms of the solicitation).

Participation Fees and Reporting of Sales to TIPS by Vendor

The Participation Fee that was published as part of the Solicitation and the fee published is the legally effective fee, along with any fee conditions stated in the Solicitation. Collection of the fees by TIPS is required under Texas Government Code §791.011 Et seq. Fees are due on all TIPS purchases reported by either Vendor or Member. Fees are due to TIPS upon payment by the Member to the Vendor, Reseller or Vendor Assigned Dealer. Vendor, Reseller or Vendor Assigned Dealer agrees that the participation fee is due to TIPS for all Agreement payments, including partial payments, from the Member Entity and must be paid to TIPS at least on a monthly basis, specifically within 31 calendar days of receipt of payment, if not more frequently, or as otherwise agreed by TIPS in writing and signed by an authorized signatory of TIPS. Thus, when an awarded Vendor, Reseller or Vendor Assigned Dealer receives any amount of payment, even partial payment, for a TIPS sale, the legally effective fee for that amount is due to TIPS from the Vendor and fees due to TIPS should be paid at least on a monthly basis, specifically within 31 calendar days of receipt of payment, if not more frequently.

Reporting of Sales to TIPS by Vendor

Vendor is required to report all sales under the TIPS contract to TIPS. When a public entity initiates a purchase with a TIPS Awarded Vendor, if the Member inquires verbally or in writing whether the Vendor holds a TIPS Contract, it is the duty of the Vendor to verify whether or not the Member is seeking a TIPS purchase. Once verified, the Vendor must include the TIPS Contract number within the mutually agreed license agreement. To report sales, the Vendor may login to the TIPS Vendor Portal online at https://www.tipsusa.com/vendors form.cfm and click on the PO's and Payments tab. Pages 3-7 of the Vendor Portal User Guide will walk you through the process of reporting sales to TIPS. Please refer to the TIPS Accounting FAQ's for more information about reporting sales and if you have further questions, contact the Accounting Team at accounting@tips-usa.com. The Vendor or vendor assigned dealers are responsible for keeping record of all sales that go through the TIPS Agreement and submitting same to TIPS. The parties acknowledge that Vendor will provide TIPS' standard Automated Vendor Report to TIPS at least every 6 months for the duration of the contract identifying all payments received under the applicable TIPS Contract. The Automated Vendor Report must be properly and fully executed except that Vendor is not required to fill out the column "Customer Number." The parties agree that Vendor will report all TIPS sales via the TIPS Automated Vendor Spreadsheet by emailing to accounting@tips-usa.com as frequently as possible but at least every six months. Failure to render the participation fee to TIPS shall constitute a breach of this agreement with our parent governmental entity, Texas Education Service Center Region 8, as established by the Texas legislature and shall be grounds for termination of this agreement and any other TIPS Contract solicited and awarded by TIPS on behalf of its TIPS Members and possible legal action. Any overpayment of participation fees to TIPS by a Vendor will be refunded to the Vendor within ninety (90) days of receipt of notification if TIPS receives written notification of the overpayment not later than the expiration of six (6) months from the date of overpayment and TIPS determines that the amount was not legally due to TIPS pursuant to this agreement and applicable law. It is



the Vendor's responsibility to identify which sales are TIPS Agreement sales and pay the correct participation fee due for TIPS Agreement sales. Any notification of overpayment received by TIPS after the expiration of six (6) months from the date of overpayment will not be refunded to Vendor, but will be credited against any future payments due to TIPS by Vendor. Region 8 ESC and TIPS reserve the right to extend the six (6) month deadline to notify if approved by the Region 8 ESC Board of Directors. TIPS reserves all rights under the law to collect the fees due. Please contact TIPS at tips@tips-usa.com or call (866) 839-8477 if you have questions about paying fees.

Vendor is required to report all sales under the TIPS contract to TIPS. When a public entity initiates a purchase with a TIPS Awarded Vendor, if the Member inquires verbally or in writing whether the Vendor holds a TIPS Contract, it is the duty of the Vendor to verify whether or not the Member is seeking a TIPS purchase. Once verified, the Vendor must include the TIPS Contract number within the mutually agreed license agreement. In the event of a conflict between a reported purchase by a TIPS Member and a report of payments by Vendor, Vendor's mutually agreed license agreement will govern. In the event that Vendor disputes a TIPS Member's usage of this Agreement to make a purchase of Vendor's goods or services, Vendor and the TIPS Member customer will work in good faith to resolve the dispute. For purposes of resolving the dispute, the deciding factor of whether a TIPS Member utilized this Agreement to make the purchase will be the member's written intent to utilize this Agreement as expressly included in the license agreement with the Vendor. If the TIPS Member wishes to move an existing license agreement with Vendor to utilize this Agreement, then the TIPS Member and Vendor must agree to do so in writing, typically via an addendum to the license agreement between the Vendor and TIPS Member.

Indemnity

The Vendor agrees to indemnify and hold harmless and defend TIPS and its officers and employees from and against all claims and suits by third parties for direct damages, injuries to persons (including death), property damages, losses, and expenses including court costs and reasonable attorney's fees, arising out of, or resulting from, Vendor's performance under this Agreement, including all such causes of action based upon common, constitutional, or statutory law, or based in whole or in part, upon allegations of negligent or intentional acts on the part of the Vendor, its officers, employees, agents, subcontractors, licensees, or invitees. Parties found liable shall pay their proportionate share of damages as agreed by the parties or as ordered by a court of competent jurisdiction over the case. NO LIMITATION OF LIABILITY FOR DAMAGES FOR PERSONAL INJURY OR PROPERTY DAMAGE UNDER THIS AGREEMENT ARE PERMITTED OR AGREED BY TIPS/ESC REGION 8. Per Texas Education Code §44.032(f), and pursuant to its requirements only, reasonable Attorney's fees are recoverable by the prevailing party in any dispute resulting in litigation. By entering into this Agreement, Vendor explicitly is not agreeing to provide this indemnity to TIPS Members; any indemnity provisions between the Vendor and TIPS Member will be negotiated and agreed to in the resulting license agreement between the Vendor and TIPS Member.

The Vendor and TIPS Members will address indemnity of each other related to Vendor's work for the Member in the required supplemental contract between the TIPS member and Vendor. Any indemnity provided by the TIPS Member to the Vendor in any supplemental contract will be limited to the extent permitted by the constitution and laws of the jurisdiction in which the TIPS Member resides.

State of Texas Franchise Tax

By signature hereon, the Vendor hereby certifies that he/she is not currently delinquent in the payment of any franchise taxes owed the State of Texas under Chapter 171, Tax Code.

Miscellaneous

A

The Vendor acknowledges and agrees that continued participation in TIPS is subject to TIPS sole discretion and that any Vendor may be removed from the participation in the Program at any time with or without cause. Nothing in the Agreement or in any other communication between TIPS and the Vendor may be construed as a guarantee that TIPS or TIPS Members will submit any orders at any time. TIPS reserves the right to request additional proposals for items or services already on Agreement at any time.

Termination for Convenience of TIPS Agreement Only

TIPS reserves the right to terminate this agreement for cause or no cause for convenience with a ninety (90) days prior written notice. The awarded Vendor may terminate the agreement with ninety (90) days prior written notice to TIPS 4845 US Hwy North, Pittsburg, Texas 75686. This termination clause does not affect the sales agreements executed by the Vendor and the TIPS Member customer pursuant to this agreement. The license agreement between the Vendor and a TIPS Member will govern any termination provisions related to that license agreement, including termination for convenience or for non-appropriation.

TIPS Member Purchasing Procedures

TIPS Members will be required to enter into a license agreement with the Vendor. TIPS Members may issue a purchase order or other supplementary order document in addition to the license agreement, however as detailed in the license agreement, the license agreement will govern the relationship between the Vendor and TIPS Member, regardless of any language contained in a purchase order or supplementary order document.

Once the Vendor and TIPS Member have entered into a mutually acceptable license agreement:

- Awarded Vendor delivers goods/services directly to the participating member.
- Awarded Vendor invoices the participating TIPS Member directly.
- Awarded Vendor receives payment directly from the participating member.
- Fees are due to TIPS upon payment by the Member to the Vendor. Vendor agrees to pay the participation fee to TIPS for all Agreement sales upon receipt of payment including partial payment, from the Member Entity or as otherwise agreed by TIPS in writing and signed by an authorized signatory of TIPS.

Licenses

Awarded Vendor shall maintain, in current status, all federal, state and local licenses, bonds and permits required for the operation of the business conducted by awarded Vendor. Awarded Vendor shall remain reasonably fully informed of and in compliance with all ordinances and regulations pertaining to the lawful provision of goods or services under the Agreement.

Novation

If awarded Vendor sells or transfers all assets, rights or the entire portion of the assets or rights required to perform this Agreement, a successor in interest must guarantee to perform all obligations under this Agreement. A simple change of name agreement will not change the Agreement obligations of awarded vendor. TIPS will consider Contract Assignments on a case by case basis. TIPS must be notified within fifteen (15) business days of the transfer of assets or rights.

Site Requirements (only when applicable to service or job)

Cleanup: If applicable, when performing work on site at a TIPS Member's property, awarded Vendor shall clean up and remove all debris and rubbish resulting from their work as required or directed by TIPS Member or as agreed by the parties. Upon completion of work, the premises shall be left in good repair and an orderly, neat, clean and unobstructed condition.

Preparation: If applicable, Awarded Vendor shall not begin a project for which TIPS Member has not prepared the site, unless awarded Vendor does the preparation work at no cost, or until TIPS Member includes the cost of site preparation in a purchase order. Site preparation includes, but is not limited to: moving furniture, installing wiring for networks or power, and similar pre-installation requirements.

Registered sex offender restrictions: For any on-site work to be performed by Vendor, Vendor agrees to work with the TIPS Member to comply with the TIPS Member's policies for background checks or sex offender requirements.

Safety Measures

If applicable, Awarded Vendor shall take all reasonable precautions for the safety of employees on the worksite, and shall erect and properly maintain all necessary safeguards for protection of workers and the public. Awarded vendor shall post warning signs against all hazards created by the operation and work in progress. Proper precautions shall be taken pursuant to state law and standard practices to protect workers, general public and existing structures from injury or damage.

Smoking

Persons working under Agreement shall adhere to the TIPS Member's or local smoking statutes, codes or policies.

Marketing

Awarded Vendor agrees to allow TIPS to use their name and logo within TIPS website, marketing materials and advertisement subject to any reasonable restrictions provided to TIPS in the Proposal to the Solicitation. The Vendor may submit an acceptable use directive for Vendor's names and logos with which TIPS agrees to comply. Any use of TIPS name and logo or any form of publicity, inclusive of press release, regarding this Agreement by awarded vendor must have prior approval from TIPS which will not be unreasonably withheld. Request may be made by email to TIPS@TIPS-USA.COM.

Supplemental Agreements

The TIPS Member entity participating in the TIPS Agreement and awarded Vendor will enter into a separate Supplemental Agreement or contract to further define the level of service requirements over and above the minimum defined in this Agreement such as but not limited to, invoice requirements, ordering requirements, specialized delivery, payment schedule, ownership of intellectual property, confidentiality, data ownership, warranties, service level agreements, indemnity, limitation of liability, dispute resolution, venue, etc. This Supplemental Agreement, if agreed to by the TIPS Member in writing, will govern the entirety of the relationship between the Vendor and the TIPS Member. Any Supplemental Agreement or contract developed as a result of this Agreement is exclusively between the TIPS Member entity customer and the Vendor. TIPS, its agents, TIPS Members and employees not a party to the Supplemental Agreement with the TIPS Member customer, shall not be made party to any claim for breach of such agreement.

Survival Clause

All applicable sales, leases, Supplemental Agreements, contracts, software license agreements, warranties or service agreements that were entered into between Vendor and TIPS or the TIPS Member Customer under the terms and conditions of this Agreement shall survive the expiration or termination of this Agreement. All Orders, Purchase Orders issued or contracts executed by TIPS or a TIPS Member and accepted by the Vendor prior to the expiration or termination of this agreement, shall survive expiration or termination of the Agreement, subject to previously agreed terms and conditions agreed by the parties or as otherwise specified herein relating to termination of this agreement. Upon termination of this Agreement, no participation fees will be due to TIPS for any payments received by Vendor after termination or expiration

this Agreement, unless those payments were already due and payable, under a license agreement or other purchase purchased and entered into under the TIPS Contract by the TIPS Member prior to such termination or expiration. For example, if the TIPS Member purchases a five-year contract with Vendor on the last active day of this Agreement and the TIPS Member makes annual payments to Vendor under that contract for the next five years, Vendor will owe participation fees on each of those payments made after termination or expiration of the TIPS Contract except in the instance that the TIPS Member Customer has amended their license agreement with Vendor to remove TIPS as the purchase vehicle for Vendor's software and services, in which case, no future payments by the TIPS Member to Vendor would result in a participation fee being due to TIPS.

Legal obligations

It is the responding Vendor's responsibility to be aware of and comply with all local, state and federal laws governing the sale of products/services identified in the applicable Solicitation that resulted in this Vendor Agreement and any awarded Agreement thereof. Applicable laws and regulations must be followed even if not specifically identified herein. TIPS acknowledges that Vendor is a Missouri domiciled corporation and must comply with Missouri law in the event of any conflicts.

Audit rights

Due to transparency statutes and public accountability requirements of TIPS and TIPS Members', the awarded Vendor shall, at their sole expense, maintain appropriate due diligence of all purchases made by TIPS Member that utilizes this Agreement. TIPS and Region 8 ESC each reserve the right to audit the accounting of TIPS related purchases for a period of three (3) years from the time such purchases are made. This audit right shall survive termination of this Agreement for a period of one (1) year from the effective date of termination. In order to ensure and confirm compliance with this agreement, TIPS shall have authority to conduct audits of Awarded Vendor's pricing or TIPS transaction documentation with TIPS Members with 30 days' notice unless the audit is ordered by a Court Order or by a Government Agency with authority to do so without notice. Notwithstanding the foregoing, in the event that TIPS is made aware of any pricing being offered to eligible entities that is materially inconsistent with the pricing under this agreement, TIPS shall have the ability to conduct the audit internally or may engage a third-party auditing firm to investigate any possible non- compliant conduct or may terminate the Agreement according to the terms of this Agreement. In the event of an audit, the requested materials shall be reasonably provided in the time, format and at the location acceptable to Region 8 ESC or TIPS. TIPS agrees not to perform a random audit the TIPS transaction documentation more than once per calendar year, but reserves the right to audit for just cause or as required by any governmental agency or court with regulatory authority over TIPS or the TIPS Member. For the avoidance of doubt, TIPS agrees to make no requests for documentation that are not specifically related to the contractual or financial details of a transaction with a TIPS member. Any audit requests that would qualify as protected or confidential customer data will provided to the TIPS Member; Vendor will not disclose TIPS Members' information that is potentially confidential.

Force Majeure

If by reason of Force Majeure, either party hereto shall be rendered unable wholly or in part to carry out its obligations under this Agreement then such party shall give notice and full particulars of Force Majeure in writing to the other party within a reasonable time after occurrence of the event or cause relied upon, and the obligation of the party giving such notice, so far as it is affected by such Force Majeure, shall be suspended during the continuance of the inability then claimed, except as hereinafter provided, but for no longer period, and such party shall endeavor to remove or overcome such inability with all reasonable dispatch.

Af

Choice of Law

The Agreement between the Vendor and TIPS/ESC Region 8 and any addenda or other additions resulting from this procurement process, however described, shall be governed by, construed and enforced in accordance with the laws of the State of Texas, regardless of any conflict of laws principles.

Venue, Jurisdiction and Service of Process

Any Proceeding arising out of or relating to this procurement process or any contract issued by TIPS resulting from or any contemplated transaction shall be brought in a State Court of competent jurisdiction in Camp County, Texas and each of the parties irrevocably submits to the exclusive jurisdiction of said court in any such proceeding, waives any objection it may now or hereafter have to venue or to convenience of forum, agrees that all claims in respect of the Proceeding shall be heard and determined only in any such court, and agrees not to bring any proceeding arising out of or relating to this procurement process or any contract resulting from or any contemplated transaction in any other court. If any action is determined to be subject to mandatory jurisdiction in Federal Court, that mandatory federal action shall be brought in the Federal Court in the Eastern District of Texas. The parties agree that either or both of them may file a copy of this paragraph with any court as written evidence of the knowing, voluntary and freely bargained for agreement between the parties irrevocably to waive any objections to venue or to convenience of forum. Process in any Proceeding referred to in the first sentence of this Section may be served on any party anywhere in the world. Venue for any dispute resolution process, other than litigation, between TIPS and the Vendor shall be located in Camp or Titus County, Texas or conducted utilizing web conferencing. For purposes of Vendor's relationship with any TIPS Member, the mutually agreed upon and executed license agreement will govern venue and any dispute resolution processes.

Project Delivery Order Procedures

The TIPS Member having approved and signed an interlocal agreement, or other TIPS Membership document, may make a request of the awarded Vendor under this Agreement when the TIPS Member desires goods or services awarded to the Vendor. Notification may occur via phone, the web, courier, email, fax, or in person. Upon notification of a pending request, the awarded Vendor shall acknowledge the TIPS Member's request as soon as possible, but must make contact with the TIPS Member within two working days. As detailed elsewhere in this Agreement, TIPS Member will be required to execute a mutually agreed upon license agreement with Vendor, prior to Vendor providing any software or services to the TIPS Member.

Status of TIPS Members as Related to This Agreement

TIPS Members shall have the same access to the proposal information and all related documents as TIPS.

Vendor's Resellers as Related to This Agreement
