Rocky is ready to go a few rounds, A\$AP

He's brash but sees himself as a regular guy, at least last

NEW YORK There's no right way to listen to A\$AP Rocky's new album.

"It's just one of those things where you get to dissect it how you want," he says, chatting in the back seat of an SUV as he heads from his SoHo penthouse to Harlem for a Q&A late one afternoon.

Perhaps self-conscious about seeming cocky, he grins and laughs, changing the subject as he points out a bikini-clad model on

a nearby billboard and asks if she's Adriana Lima. (She isn't.) Still, it's not unreasonable to

expect greatness from the 26-year-old's new album, At.Long.Last, A\$AP (out June 2).

The Harlem-bred rapper (born Rakim Meyers) has been touted as one of hip-hop's best upstarts ever since his breakout 2011 mixtape, Live. Love. A\$AP.

With this album, "I'm gonna just come back and get people to the music again," Rocky says. "You know what I hate hearing? 'He's handsome; he's (with) this chick.' I don't need the attention of being a celebrity. I'm a regular (guy), man."

Stooges and T. Rex. The sonic shift is most evident on the stirring Everyday, a bluesier cut produced by Mark Ronson (megahit Uptown Funk), with vocals from Rod Stewart (via a sample of Python Lee Jackson's In a Broken Dream) and Miguel.

A regular guy whose relationships with rapper Iggy Azalea and model Chanel Iman have generated some tabloid fodder the past few years, as did his arrest for allegedly attacking two photographers in New York in 2012.

But for the most part, he has been able to avoid the pitfalls of fame — instead establishing himself as a fashion icon and making

his film debut in the Sundance hit Dope (in theaters June 19). He also is finishing a solo album by his longtime mentor, the late A\$AP Yams, who died of an accidental drug overdose in January at age 26.

As he nears the venue, Rocky says he'd like to "change the world with (his) music" and help people not feel like outsiders.

It's a point he comes back to in his conversation with moderator Jeff "Chairman" Mao at the sold-out Q&A.

Asked by Mao if he sees himself as a "weirdo" or an outcast, Rocky says, "Yeah, I still feel like that. But I'm just comfortable with me."

But "as a counterargument," Mao continues, "you make cool music, you're well-dressed, you're lucky. We should all be such lucky weirdos." Rocky chuckles. "That was the depest compliment/insult ever."

Fresh 'Hell': Duchovny's new album is out there

The actor-author adds music to his list

David Duchovny released his first novel in February, his new NBC TV series *Aquarius* premieres in May, and Fox is reviving his '90s hit *The X-Files*.

About the only thing he doesn't have in the works is an album.

Oh, wait. He does.

On May 12, Duchovny will release his first album, *Hell or Highwater*, on ThinkSiya Records. It contains 12 songs written by Duchovny. He's backed by a group of musicians who perform sep-

arately under the name Weather and give his songs a '90s-rock feel in the vein of The Wallflowers and the Gin Blossoms.

Duchovny says he began playing guitar several years ago. "I bought an expensive guitar, because I knew I was too cheap to not play it." After a while, he began sitting in with Los Angeles singer-songwriter Keaton Simons and writing his own songs.

The album's title track and first single is a love song that harbors no romantic illusions. Duchovny sings, "I said I'd love you forever, come hell or high water/Baby, the flood's in." It's available for digital download.

The final song, *Positively Madison Avenue*, was inspired by seeing Bob Dylan's ad for Chrysler

that premiered during the Super Bowl. The song plays like a direct message to Dylan — Duchovny sings, "Only you could write the song that could get to you." Duchovny says he used his feelings about Dylan as a symbol of integrity as a starting point to grapple with his own issues about selling out. "My nightmare would be that Bob hears the song and is insulted and cares to respond," he says. "Because I lose."

Duchovny plans to appear with the band but hasn't booked a tour.

"I'm lucky enough to be able to book some really great TV spots and get exposure that a normal new artist, which is what I guess I am in this field, wouldn't be able to get," he says.

"I'm learning what it's like to sing with a live band, how close to be to the mic, learning about singing period," he says. "I hope that I get to discover certain things before the audience does, so it's not too painful."

The new run of *X-Files* episodes will begin shooting in June in Vancouver, Duchovny says, so he'll have about a month after the album's release to play any shows, if there's a demand for them.

He says he knows nothing about the story arc for the miniseries.

"All I know is I've been trying to make (series creator) Chris Carter use my music," he says. "I never could do that before."

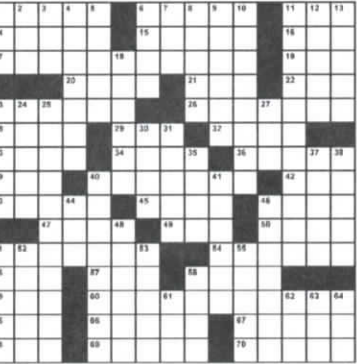

'Moon' marks the band's new phase of collaboration

STILL IN ORBIT Since 1987, Blues Traveler has made its mark in the "middle class of rock 'n' roll," says frontman John Popper. Hits in the mid-'90s like Run-Around and Hook have been followed by well-received albums, all leading up to this week's release of 13th studio album Blow Up the Moon.

TRUE TO SELF: "I think it's important for a band to constantly be doing new things in order to keep its identity," Popper says. Each song on Moon - from the chill, reggae sounds of Castaway to the upbeat, silly lyrics in I Know Right - displays the band's creative avocations. "When you have a different relationship artistically with someone, you discover a new power that you have, a new aspect to yourself, a new context to put yourself in. And that's sort of the fun part about getting older."

SOCIAL BUTTERFLY: Since Blues Traveler was founded in 1987 in Princeton, N.J., technology and the Internet have shifted the way the band's music has been produced. The group has made a point - especially while writing this album - to use social media

outlets as a way to keep up with fans and find inspiration. "Connecting with fans is really awesome," says Popper, 48. "What I love about Twitter is that it's all one-liners, so it's kind of hostile. It's sort of like road rage but nobody gets hurt."

THE BLUES BROTHERHOOD. After almost three decades of playing together, Popper, Chan Kinchla, Tad Kinchla, Brendan Hill and Ben Wilson have become more than just bandmates. "It's the same as it's always been in that these are my brothers, so there's times when I can't stand them and times when I love them more than anything," Popper says. "It's a family. And we've been going at this for almost 30 years now, so whatever we go through, we go through together."

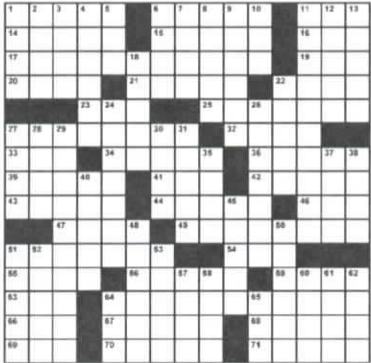
