

Bryan gets down and dirty with 'Kick the Dust Up'

Anyone who caught the first two nights of Luke Bryan's Kick the Dust Up Tour last week probably has a good idea what his next single will be.

Kick the Dust Up, which goes to radio and is available for digital download Tuesday, not only gave the country star's tour its name, but it kicks off his shows, too.

"That's how confident we are in the song being pretty awe-some," says Bryan, who has never used an unreleased song as his set opener before. "We figured the socials would start lighting up and people would start learning he words. Once it his radio, people will catch on real quick."

The song, a four-on-the-floor stomp with a guitar hook doubled by a banjo, comes from the pens



of Dallas Davidson, Chris DeSte-

of Dallas Davidson, Chris DeSte-fano and Ashley Gorley, the same team behind Bryants 2013 smash That's My Kied of Night. Bryan says he knew in January when he announced his summer-tour that Kiek the Daut Up would be a crucial track, both in concert and on his next album, due later this year. "We recorded a lot of songs, and that one stood he test of time. It's a big, anthemic sing-slong, so it should be pretty fun." Bryan unveiled the song during a string of Canadian dates this month. The Academy of Country Music's reigning entertainer of the year will perform it on The Ellen DeGeneres Show and on the

Ellen DeGeneres Show and on the season finale of The Voice, both of

season finale of The Voice, both of which air Tuesday. He'll also be the subject of an exhibit at Nashville's Country Music Hall of Fame and Museum opening May 22 (through Nov. 8). In addition to career memorabil-

ia, it will display his second-grade backpack, his childhood baseball uniform and a script from one of his high school plays. "It's a flattering gesture," he says.

Beyan's tour, which resumes Thursday in Boise, includes staditum shows in Denver, St. Paul, Nashville, Cincinnati, San Francisco and Cleveland.

Should Bryan ever decide he needs time off from the road, friend Blake Shelton might have just the thing. The Vière coach recently told the Associated Press that Bryan would be a good choice to fill his seat should Shelton decide to leave the show.

Bryan says he would be open to that, "as long as I can get the Blake Shelton contract."

"First and foremost, I love to tour and be on stage. That's where the rubber meets the road for me. But I would never say never to anything like that."






