



# MATURING **OFFENSE LIFTS HURRICANES**

With No. 2 Florida State on horizon, Miami picks perfect time to coalesce

As the University of Miami (Fla) quietly pieced together its recent three-game winning streak; two truths emerged. The first: True freshman quarterback Brad Kaway an longer is playing like a true freshman, having completed 61% of his passes during the stretch for 567 yards, seven touchdowns and zero interceptions. The second Junior running back Duke Johnson, the Hurricanes workhorse, has gained 588 rushing yards and scored four touchdowns over the same span. He has rushed for at least 100 yards in five consecutive games, and he's closing in on Miami's all-time rushing record.

After Miami's 47-20 thrashing of North Carolina last weekend,


