# MADISON, HARRISBURG, NEWARK AMONG PRICEST AIRPORTS IN '15

Wisconsin's Dane County Regional had average fare of \$512

With the spread of discount airlines across the country, some fliers have come to expect airfare deals. But those may have been hard to come by last year at a handful of airports that had the highest ticket prices in the U.S.

"When you have less competition, fewer seats and strong demand from a region, you have the ability to raise fares," says Scott Miller, spokesman for Harrisburg International Airport in Pennsylvania, where the average domestic fare was \$480.32 in the third quarter of 2015. That's the second highest among the nation's top 100 airports. "To the consumer, it's frustrating because they have a facility they want to use, but not everybody can afford the high fare, and they're forced to drive hours to fly."

Only Dane County Regional Airport in Madison, Wis., topped Harrisburg, with an average domestic fare of \$511.58. And while the others among the top five also tended to be smaller airports — Knoxville's McGhee Tyson and Fresno Yosemite International Airport in California — there's also a big airport on the list: Newark Liberty.

"Newark's high fares can be explained in part by it being a fortress hub for United," said travel industry analyst Henry Harteveldt. United carried 68.4% of the airport's passengers last year. "As a result, budget airlines such as Frontier and Spirit, which tend to

offer lower fares, have a very limited presence."

Newark also has numerous long-haul flights, which tend to be pricier. And airports like Newark that have a high proportion of business travelers often show higher average fares. That's because business fliers typically pay more for last-minute bookings, or for seats in the premium cabins.

But another key factor behind some airports' lofty fares is airlines having the upper hand when it comes to pricing. In Madison, for instance, Delta controls 52% of the market share, says Dane County Regional airport spokesman Brent McHenry, making it easier for the carrier to boost fares because of a lack of competition. And across the industry, airlines have fine-tuned the balance between the number of seats they offer and passenger demand, enabling them to charge more.


Knoxville's McGhee-Tyson Airport is constantly on the search for new service in order to bring fares down, says airport spokeswoman Becky Huckaby. In May, low-cost carrier Allegiant will add two new routes to Baltimore and Las Vegas.

"We are always actively trying to recruit new service from incumbent carriers as well as new airlines to create competition, which has a positive impact on lowering airfares," says Huckaby, adding that the airport is currently served by Allegiant, American, Delta and United and it has seasonal flights from Frontier.

Harrisburg International, which mirrors Knoxville in serving a significant number of business travelers, saw 1.2 million passengers last year, and Miller says it could handle 2 million fli-

ers based on population and demand.

However, Frontier pulled up stakes in Harrisburg last year,

shifting service to Philadelphia, Miller says. Several other airlines — Allegiant, Delta, American, United and Air Canada — remain, but they have "shrunk capacity to the point ... they can set fares at this level, and business travelers will pay for the convenience of using Harrisburg vs. driving," though many fliers "not able to (pay) the premium, or who don't want to, are forced to drive hours, and they do."

The loss of passengers to Baltimore and Philadelphia affects the fortunes of both the Harrisburg airport and the broader community, Miller says.

There are other factors that influence ticket prices.

For instance, "Madison has a high percentage of business travelers," McHenry says. "In comparison to leisure travelers, they book tickets very last-minute, routinely purchase first-class fares, as well as fully refundable tickets, which can inaccurately inflate the average ticket price" as calculated by the Bureau of Transportation Statistics.

The tax portion of a ticket has also risen, McHenry says. Currently 21% of a \$300 ticket is taxes, according to the trade group Airlines for America. Still, overall, the average domestic ticket price in the third quarter of last year was \$372, the lowest since 2010.

"Air travel remains one of the best consumer bargains out there, as evidenced by the increase in the number of people flying," says Melanie Hinton, spokeswoman for Airlines for America.

"The strength of demand, as well as the cost of serving a specific airport, and competition is what ultimately drives traffic and fares."

# Herbalife admits it overstated figures

Says in SEC filing that it misreported active new members

Nutrition company Herbalife acknowledged Thursday that it had overstated its membership figures in an admission that could fuel more scrutiny of the company's business model.

The company said in a Securities and Exchange Commission filing that it had misreported "active new member" figures.

Herbalife has faced multiple federal investigations over its business practices and accusations from hedge fund investor Bill Ackman that the company is running an illegal pyramid scheme. Herbalife has denied those allegations and accused Ackman of stock manipulation.

The company blamed its misstated membership figures on "database scripting errors" and "quarterly aggregation issues." Herbalife stock (HLF) fell 7.4% in afternoon trading to \$52.20.

The drop came after investors last week drove shares skyward after Herbalife said it was negotiating a resolution to the Federal Trade Commission's probe.

The company said worldwide new active members rose 3.2% in Q4 2015, compared with a year earlier, not 16.7% as it reported last week. It said U.S. active new members rose 30.7% during the same period, not the 71% it previously stated.

Altogether, Herbalife corrected 28 different statements tied to the new active member figures.

"The company did not discover these errors earlier because it had limited visibility into the likely rate of change in this metric upon its first use," the company said in a statement.

"The company has taken corrective action regarding these issues."

# Up-and-coming artists flipping over Flipagram

The app, a mix of Instagram and YouTube, pairs photos and videos with music

LOS ANGELES She's on Vine, Instagram, Snapchat and Twitter. But the social app of choice for classically-trained pop singer Emm is Flipagram.

"I just passed 100,000 fans" on Flipagram, which marries smartphone videos and photos with popular music. "Yeah!"

Some 40 million folks monthly (from around 10 million a year ago) visit the Instagram-meets-YouTube free app to repack their smartphone photos and videos with popular music, everything from the latest Justin Bieber hit to a classic from Frank Sinatra. Photo/video sharing growth rate of 300% year-over-year has lured in big investors such as Sequoia Capital and Kleiner Perkins.

Five billion photos and videos are shared monthly on the app — a rate that's getting closer to the 8 billion videos viewed every day each on both Snapchat and Facebook.

Some of the Los Angeles-based start-ups enthusiasts are emerging artists such as Emm, who use it to showcase their music to new fans. She found a manager and club dates just by posting videos with her music to the app.

Others just want to share their photos in a form that's different from an Instagram collage. The 3-year-old company, co-founded by serial entrepreneur Farhad Mohit, is offering a visual-first culture a new way to share their products: music.

"People, especially younger Millennials, take so many pictures during the day," he says. "They speak and communicate daily with pictures."

Beyond up-and-coming talent, big-name celebrities such as Beyonce, Justin Timberlake, Channing Tatum and Madonna have discovered the app and have posted their own photo/video music slideshows.

And the app has blue-chip financing behind it: \$70 million from Sequoia Capital, Kleiner Perkins Caufield and Byers, and Index Ventures, in the latest financing round, announced in 2015. The company won't comment on valuation, but *TechCrunch* recently estimated it at more than \$300 million.

"There's a reason celebrities have found it (Flipagram)," Michael Moritz, the chairman of Sequoia, told USA TODAY. "It answers a need for them that

they can't get on Instagram, Facebook or Snapchat, a way to weave in stills and videos simply with music." Moritz is a longtime investor in such companies as Google, Yahoo and PayPal. He serves on the Flipagram board of directors with Kleiner Perkins partner John Doerr.

While the app is free, Flipagram brings in money by selling the right to remove the Flipagram watermark for \$1.99 a pop.

The company's main focus is on user growth. But it's competing in a crowded arena.

There are dozens of apps to make music videos from photos and videos (like musical.ly and Vidity) and apps to either collect or share photos. Facebook's "Moments" app bunches Camera Roll photos and videos together, for

instance. And Facebook's Instagram is the No. 1 photo-sharing app, with 400 million monthly users and 40 billion photos shared to date.

Flipagram distinguishes itself in two ways: length of social video and its music library.

Similar social products are much shorter: Vine's are only 6 seconds long and Instagram videos 15 seconds, but Flipagram lets folks go as long as 60 seconds.

And Facebook, Instagram and Vine don't have tools to merge pictures and videos with licensed music like Flipagram does.

That's a key part of Flipagram's recent success, Mohit says.

Two years after Mohit, 47, started Flipagram, he made deals with the major record labels to allow usage of current and library songs to be featured legally in Flipagram videos. It took 14 months to conclude the deals.

Flipagram had offered song snippets via iTunes, but "we weren't licensed for it," Mohit says. "That put a huge liability over the company. It was like a big sword over our head."

Having the music and storytelling tools is Flipagram's big differentiator, Mohit says.

Pulling photos and videos from your smartphone into a story with a beginning, middle and end — and music — "is an overwhelming thing," he says. "It's like the first time I tried Instagram. I felt like I was an artist when I put a filter on the photo."

Before Flipagram, Mohit, an Iranian born immigrant who came to the U.S. as a small child, started two business rating online sites, Shopzilla and Bizrate, which he sold to Scripps Howard for \$525 million.

# JPMorgan's tech offices take page from Google

More-relaxed atmosphere allows jeans, Foosball, Xbox

NEW YORK As more banking activities move online, JPMorgan Chase & Co. is shedding its pinstriped suits and stodgy offices in a bid to win over coders and engineers.

JPMorgan, the nation's largest bank by assets, opened a digital hub in Manhattan's Hudson Yards neighborhood in December to house 700 tech workers. Unlike its more traditional Park Avenue headquarters, the digital team is allowed to wear jeans, ride around the office on scooters and play Foosball and Xbox at work.

If that sounds a lot like tech giant Google, it's because it is. Executives with the digital team talked to executives at Google, Amazon and other tech companies about how to best design the space to spur innovation, said James Young, the chief information officer for the bank's digital unit.

What they came up with was three football fields of open-floor space that is designed to encourage casual meetings and brainstorming sessions.

"There are more seats away from desks than at desks," Young said. "We don't want people spending their day looking at email," he said.

For Mario Pedernera, a program manager, the new space has given way to "democracy with a lowercase 'd.'" It encourages workers "fresh out of college" to share ideas with the team's top executives at open-space meetings, he said.

The move highlights the emphasis the bank is putting on online and mobile banking, including plans later this year for Chase Pay, a digital payment system that will compete with Apple Pay, Android Pay and Samsung Pay.

Like its Silicon Valley competitors, Chase Pay will let people use their phones to pay for things in stores and restaurants.

Thursday, Chase launched a redesign of its retail banking website, chase.com, as part of its ongoing effort to service and encourage the move away from bank branches.




