

Annie slowly loses her mind in the wake of insurmountable loss. She re-creates traumatic scenes from her life using painted miniatures and doll-houses, and befriends a mysterious woman (Ann Dowd) who communicates with the dead.

Collette, 45, found it easy to sympathize with Annie, despite the character's lingering resentment about motherhood. "There are so many despicable moments when she seems so unlikely and self-absorbed, and isn't a very good mother," Collette says. But in the end, "she's so repressed and so protective of her family. She's lived with this (curse) her whole life — this knowledge that something is definitely wrong — and can't understand what it is. It's total torture."

The actress, who also stars in indie comedy *Hearts Beat Loud* this month, left her two kids (ages 7 and 10) and musician husband Dave Galafassi at home in Los Angeles when she shot the film in Utah last year. But unlike Jennifer Lawrence (*mother!*) and Dakota Johnson (*Suspiria*) — who reported getting physically ill and needing therapy while shooting their

your knees, just screaming, and then, 'OK! Off to the (snack) table.'"

recent forays into horror — Collette assures us she made it out with her health and mind intact. "I have had experiences like that on other films," Collette says, laughing. "Upon reading (*Hereditary*), I knew it would demand even more of me and I needed to take care of myself. I just found a way of shaking it off day by day, rather than letting it accumulate and explode at the end of the job."

Adds Aster: "It was amazing to see you, because there are some scenes when you're just howling in anguish, but you'd stroll in like, 'Hey, guys! What'd you have for breakfast?' And when I yelled cut, you'd be on

horrific trauma, and their powers manifest as a metaphor for post-traumatic stress disorder, forcing them to relive the worst parts of their lives, often quite literally through their vision powers. Every scene in which they use their powers is deeply emotional; this is a superhero show for fans who prefer meaning over martial arts.

Holt (a former Disney Channel star) and Joseph are appealing young talents with good chemistry and puppy-dog eyes. The acting is more natural than typical superhero dramas. The pilot is directed by Gina Prince-Bythewood (*Love and Basketball*), who gives the series, set and filmed in New Orleans, a leisurely style, and plays with the light/dark dichotomy that is part of Tandy and Tyrone's powers.

Wisely, the series shirks the racial stereotypes and sexist costumes of the dated comics on which it's based and doesn't shy away from racial issues.



Tyrone (Aubrey Joseph) can teleport, and both "Cloak and Dagger" heroes have visions.

Tyrone's mother fears he could be killed by police, he's bullied by white teammates on his basketball team, and he fears being perceived as a thug.

Cloak and Dagger isn't a joyful series — it's an often somber coming-of-age story of two kids deeply traumatized but trying to heal — but it's joyful to watch it unfold. And isn't that how a superhero should make you feel?

‘Traveling Feast’: Fill up on wisdom

Writers get together for dinner, and sharing

Defeated from a divorce and searching for meaning in middle age, a renowned writer seeks answers through travel, cooking and community.


In “The Traveling Feast: On the Road and at the Table with My Heroes” (Little, Brown, 288 pp., ★★☆☆), Rick Bass brings his writing apprentices to the homes of his own mentors and well-known writers he admires, to offer a meal, express gratitude and connect generations in the industry.

Bass, 60, an accomplished writer and teacher, is emerging from years of relative isolation in Montana while in the midst of a divorce. Keenly aware of time passing and age advancing (his own and that of his contemporaries), he’s eager to glean wisdom from his favorite writers — Gordon Lish, Joyce Carol Oates and David Sedaris among them — while he can.

Over the course of three years, he

flies and drives to whomever is available to accept a meal, with four or five aspiring writers in tow.

Bass brings frozen cuts of an elk he hunted in Montana, along with whatever he and his travel companions can prep in advance, to serve a meal of meat and seasonal accompaniments in each host’s kitchen, “something ceremonial beyond the unimaginative twenty-first-century gesture of picking up the damned tab.”

Bass and nearly ever writer featured prove to be astute cooks, borderline food snobs in their own local ways (Bass forages and hunts at home while a New Jersey writer prefers fine restaurants), and the conversations tend to revolve around food and life lessons more than writing.

Each chapter retells one visit to a writer, whether for a picnic or dinner

party, and each experience is brief and to the point. Some end abruptly without a mention of what the writer shared with the younger visitors, but we learn something at each stop.

Bass finds almost every friend has a neat and organized private writing space, and less expectedly, many face away from scenic windows while working. On a deeper level, each host’s approach to life, love, nature or time is revealed with quotes that will stick with you.

“Traveling Feast” is a series of stories about travel and food, as each menu is meticulously detailed, and the adventurous and challenging aspects of road trips (and travel abroad) are inevitably explored. But it becomes more a story of life morals. Bass is collecting advice and credos from each host in search of inspiration to move forward in his life and career.

Bass is admittedly running, unraveling and procrastinating in this attempt to process or cure his pain and perhaps redefine his identity. Is his intention to help other writers or leave a legacy of his own? Only time and literature will tell if either effort succeeds.
