#### **General Information**

The Vendor Agreement ("Agreement") made and entered into by and between The Interlocal Purchasing System (hereinafter referred to as "TIPS" respectfully) a government cooperative purchasing program authorized by the Region 8 Education Service Center, having its principal place of business at 4845 US Hwy 271 North, Pittsburg, Texas 75686. This Agreement consists of the provisions set forth below, including provisions of all Attachments referenced herein. In the event of a conflict between the provisions set forth below and those contained in any Attachment, the provisions set forth shall control.

The vendor Agreement shall include and incorporate by reference this Agreement, the terms and conditions, special terms and conditions, any agreed upon amendments, as well as all of the sections of the solicitation as posted, including any addenda and the awarded vendor's proposal. Once signed, if an awarded vendor's proposal varies or is unclear in any way from the TIPS Agreement, TIPS, at its sole discretion, will decide which provision will prevail. Other documents to be included are the awarded vendor's proposals, task orders, purchase orders and any adjustments which have been issued. If deviations are submitted to TISP by the proposing vendor as provided by and within the solicitation process, this Agreement may be amended to incorporate any agreed deviations.

The following pages will constitute the Agreement between the successful vendors(s) and TIPS. Bidders shall state, in a separate writing, and include with their proposal response, any required exceptions or deviations from these terms, conditions, and specifications. If agreed to by TIPS, they will be incorporated into the final Agreement.

#### **Definitions**

**PURCHASE ORDER** is the TIPS member's approval providing the authority to proceed with the negotiated delivery order under the Agreement. Special terms and conditions as agreed to between the vendor and TIPS member will be added as addendums to the PO. Items such as certificate of insurance, bonding requirements, small or disadvantaged business goals are some of the addendums possible.

## **Terms and Conditions**

#### Freight

All quotes to members shall provide a line item for cost for freight or shipping regardless if there is a charge or not. If no charge for freight or shipping, indicate by stating "No Charge" or "\$0" or other similar indication.

#### **Warranty Conditions**

All supplies equipment and services shall include manufacturer's minimum standard warranty unless otherwise agreed to in writing. Vendor shall be an authorized dealer, distributor or manufacturer for all products. All equipment proposed shall be new unless clearly stated in writing.

#### **Customer Support**

The Vendor shall provide timely and accurate customer support to TIPS members. Vendors shall respond to such requests within one (1) working day after receipt of the request. Vendor shall provide training regarding products and services supplied by the Vendor unless otherwise clearly stated in writing at the time of purchase. (Unless training is a line item sold or packaged and must be purchased with product.)

#### **Agreements**

All Agreements and agreements between Vendors and TIPS Members shall strictly adhere to the statutes that are set forth in the Uniform Commercial Code as most recently revised.

Agreements for purchase will normally be put into effect by means of a purchase order(s) executed by authorized agents of the participating government entities.

Davis Bacon Act requirements will be met when Federal Funds are used for construction and/or repair of buildings.

#### Tax exempt status

A taxable item sold, leased, rented to, stored, used, or consumed by any of the following governmental entities is exempted from the taxes imposed by this chapter:(1) the United States; (2) an unincorporated instrumentality of the United States; (3) a corporation that is an agency or instrumentality of the United States and is wholly owned by the United States or by another corporation wholly owned by the United States;(4) the State of Texas; (5) a Texas county, city, special district, or other political subdivision; or (6) a state, or a governmental unit of a state that borders Texas, but only to the extent that the other state or governmental unit exempts or does not impose a tax on similar sales of items to this state or a political subdivision of this state. Texas Tax Code § 151.309.

#### **Assignments of Agreements**

No assignment of Agreement may be made without the prior written approval of TIPS. Payment can only be made to the awarded Vendor or vendor assigned dealer.

#### **Disclosures**

- Vendor affirms that he/she has not given, offered to give, nor intends to give at any time hereafter any economic opportunity, future employment, gift, loan, gratuity, special discount, trip, favor or service to a public servant in connection with this Agreement.
- Vendor shall attach, in writing, a complete description of any and all relationships that might be considered a conflict of interest in doing business with participants in the TIPS program.
- 3. The vendor affirms that, to the best of his/her knowledge, the offer has been arrived at independently, and is submitted without collusion with anyone to obtain information or gain any favoritism that would in any way limit competition or give an unfair advantage over other vendors in the award of this Agreement.

#### **Renewal of Agreements**

The Agreement with TIPS is for one (1) year with an option for renewal for additional consecutive years as provided in the solicitation. Total term of Agreement can be up to the number of years provided in the solicitation, if sales are reported through the Agreement and both parties agree.

Automatic Renewal Clauses Incorporated in Awarded Vendor Agreements with TIPS Members Resulting from the Solicitation and with the Vendor Named in this Agreement.

No Agreement for goods or services with a TIPS member by the awarded vendor named in this Agreement that results from the solicitation award named in this Agreement, may incorporate an automatic renewal clause with which the TIPS member must comply. All renewal terms incorporated in an Agreement by the vendor with the TIPS member shall only be valid and enforceable when the vendor receives written confirmation by purchase order or executed Agreement issued by the TIPS member for any renewal period. The purpose of this clause is to avoid a TIPS member inadvertently renewing an Agreement during a period in which the governing body of the TIPS member has not properly appropriated and budgeted the funds to satisfy the Agreement renewal. This term is not negotiable and any Agreement between a TIPS member and a TIPS awarded vendor with an automatic renewal clause that conflicts with these terms is rendered void and unenforceable.

#### **Shipments**

The Vendor shall ship ordered products within a commercially reasonable time after the receipt of the order. If a product cannot be shipped within that time, the Vendor shall notify TIPS and

the requesting entity as to why the product has not shipped and shall provide an estimated shipping date, if applicable. TIPS or the requesting entity may cancel the order if estimated shipping time is not acceptable.

#### **Invoices**

The Vendor or vendor assigned dealer shall submit invoices, to the TIPS participant. Each invoice shall include the TIPS participant's purchase order number. The shipment tracking number or pertinent information for verification of TIPS participant receipt shall be made available upon request. The Vendor or vendor assigned dealer shall not invoice for partial shipments unless agreed to in writing in advance by TIPS and the TIPS participant.

#### **Payments**

The TIPS participant will make payments directly to the Vendor or vendor assigned dealer at net 30 days after receiving invoice.

#### **Pricing**

The Vendor agrees to provide pricing to TIPS and its participating governmental entities that is at least equal to the lowest pricing available to like cooperative purchasing customers and the pricing shall remain so throughout the duration of the Agreement.

The Vendor agrees to promptly lower the cost of any product purchased through TIPS following a reduction in the manufacturer or publisher's direct cost to the Vendor. Price increases will be honored according to the terms of the solicitation. However, the Vendor shall honor previous prices for thirty (30) days after written notification to TIPS of an increase.

All pricing submitted to TIPS shall include the participation fee, as provided in the solicitation, to be remitted to TIPS by the Vendor. Vendor will not show adding the fee to the invoice presented to customer. Failure to render the participation fee to TIPS shall constitute a breach of this agreement and shall be grounds for termination of this agreement and any other agreement held with TIPS.

#### **Participation Fees**

Vendor or vendor assigned dealer Agreements to pay the participation fee for all Agreement sales to TIPS on a monthly scheduled report. Vendor must login to the TIPS database and use the "Submission Report" section to report sales. The Vendor or vendor assigned dealers are responsible for keeping record of all sales that go through the TIPS Agreement. Failure to pay the participation fee will result in termination of Agreement. Please contact TIPS at tips@tips-usa.com or call (866) 839-8477 if you have questions about paying fees.

#### Indemnity

- 1. Indemnity for Personality Agreements. Vendor agrees to indemnify and hold harmless and defend TIPS, TIPS member(s), officers and employees, from and against all claims and suits for damages, injuries to persons (including death), property damages, losses, and expenses including court costs and attorney's fees, arising out of, or resulting from, Vendor's performance of this Agreement, including all such causes of action based upon common, constitutional, or statutory law, or based in whole or in part, upon allegations of negligent or intentional acts on the part of the Vendor, its officers, employees, agents, subcontractors, licensees, invitees, whether or not such claims are based in whole or in part upon the negligent acts or omissions of the TIPS, TIPS member(s), officers, employees, or agents.
- 2. Indemnity for Performance Agreements. The Vendor agrees to indemnify and hold harmless and defend TIPS, TIPS member(s), officers and employees from and against all claims and suits for damages, injuries to persons (including death), property damages, losses, and expenses including court costs and attorney's fees, arising out of, or resulting from, Vendor's work under this Agreement, including all such causes of action based upon common, constitutional, or statutory law, or based in whole or in part, upon allegations of negligent or intentional acts on the part of the Vendor, its officers, employees, agents, subcontractors, licensees, or invitees. Vendor further agrees to indemnify and hold harmless and defend TIPS, TIPS member(s), officers and employees, from and against all claims and suits for injuries (including death) to an officer, employee, agent, subcontractors, supplier or equipment lessee of the Vendor, arising out of, or resulting from, Vendor's work under this Agreement whether or not such claims are based in whole or in part upon the negligent acts or omissions of the TIPS, TIPS member(s), officers, employees, or agents.

#### Attorney's Fees--Texas Local Government Code § 271.159 is expressly referenced.

Pursuant to §271.159, Texas Loc. Gov'T Code, in the event that any one of the Parties is required to obtain the services of an attorney to enforce this Agreement, the prevailing party, in addition to other remedies available, shall be entitled to recover reasonable attorney's fees and costs of court.

#### **Multiple Vendor Awards**

TIPS reserves the right to award multiple vendor Agreements for categories when deemed in the best interest of the TIPS membership. Bidders scoring the RFP's specified percentage or above will be considered for an award. Categories are established at the discretion of TIPS.

#### **State of Texas Franchise Tax**

By signature hereon, the bidder hereby certifies that he/she is not currently delinquent in the payment of any franchise taxes owed the State of Texas under Chapter 171, Tax Code.

#### Miscellaneous

The Vendor acknowledges and agrees that continued participation in TIPS is subject to TIPS sole discretion and that any Vendor may be removed from the participation in the Program at any time with or without cause. Nothing in the Agreement or in any other communication between TIPS and the Vendor may be construed as a guarantee that TIPS participants will submit any orders at any time. TIPS reserves the right to request additional proposals for items already on Agreement at any time.

#### **Purchase Order Pricing/Product Deviation**

If a deviation of pricing/product on a purchase order occurs, TIPS is to be notified within 48 hours of receipt of order.

#### **Termination for Convenience**

TIPS has the right to terminate the agreement for cause or no cause for convenience with a thirty-day written notice. Termination for convenience is required under 2 CFR part 200.

#### **TIPS Member Purchasing Procedures**

Purchase orders or their equal are issued by participating TIPS member to the awarded vendor indicating on the PO "Agreement Number". Order is emailed to TIPS at tipspo@tips-usa.com.

- Awarded vendor delivers goods/services directly to the participating member.
- Awarded vendor invoices the participating TIPS member directly.
- Awarded vendor receives payment directly from the participating member.
- Awarded vendor reports sales monthly to TIPS (unless prior arrangements have been made with TIPS to report monthly).

#### Form of Agreement

If a vendor submitting an offer requires TIPS and/or TIPS Member to sign an additional agreement, a copy of the proposed agreement must be included with the proposal. In response to submitted supplemental Vendor Agreement documents, TIPS will review proposed vendor Agreement documents. Vendor's Agreement document shall not become part of TIPS's Agreement with vendor unless and until an authorized representative of TIPS reviews and approves it.

#### Licenses

Awarded vendor shall maintain in current status all federal, state and local licenses, bonds and permits required for the operation of the business conducted by awarded vendor. Awarded vendor shall remain fully informed of and in compliance with all ordinances and regulations pertaining to the lawful provision of services under the Agreement. TIPS reserves the right to stop work and/or cancel Agreement of any awarded vendor whose license(s) expire, lapse, are suspended or terminated.

#### Novation

If awarded vendor sells or transfers all assets or the entire portion of the assets used to perform this Agreement, a successor in interest must guarantee to perform all obligations under this Agreement. TIPS reserves the right to accept or reject any new party. A simple change of name agreement will not change the Agreement obligations of awarded vendor.

#### Site Requirements (when applicable to service or job)

Cleanup: Awarded vendor shall clean up and remove all debris and rubbish resulting from their work as required or directed by TIPS Member. Upon completion of work, the premises shall be left in good repair and an orderly, neat, clean and unobstructed condition.

Preparation: Awarded vendor shall not begin a project for which TIPS Member has not prepared the site, unless awarded vendor does the preparation work at no cost, or until TIPS Member includes the cost of site preparation in a purchase order.

Site preparation includes, but is not limited to: moving furniture, installing wiring for networks or power, and similar pre-installation requirements.

Registered sex offender restrictions: For work to be performed at schools, awarded vendor agrees that no employee of a sub-contractor who has been adjudicated to be a registered sex offender will perform work at any time when students are or reasonably expected to be present.

Awarded vendor agrees that a violation of this condition shall be considered a material breach and may result in the cancellation of the purchase order at the TIPS Member's discretion. Awarded vendor must identify any additional costs associated with compliance of this term. If no costs are specified, compliance with this term will be provided at no additional charge. Safety measures: Awarded vendor shall take all reasonable precautions for the safety of employees on the worksite, and shall erect and properly maintain all necessary safeguards for protection of workers and the public. Awarded vendor shall post warning signs against all hazards created by the operation and work in progress. Proper precautions shall be taken pursuant to state law and standard practices to protect workers, general public and existing structures from injury or damage.

#### Smoking

Persons working under Agreement shall adhere to local smoking policies. Smoking will only be permitted in posted areas or off premises.

#### **Invoices**

The awarded vendor shall submit invoices to the participating entity clearly stating "Per TIPS Agreement". The shipment tracking number or pertinent information for verification shall be made available upon request.

#### Marketing

Awarded vendor agrees to allow TIPS to use their name and logo within website, marketing materials and advertisement. Any use of TIPS name and logo or any form of publicity, inclusive of press release, regarding this Agreement by awarded vendor must have prior approval from TIPS.

#### Supplemental agreements

The entity participating in the TIPS Agreement and awarded vendor may enter into a separate supplemental agreement to further define the level of service requirements over and above the minimum defined in this Agreement i.e. invoice requirements, ordering requirements, specialized delivery, etc. Any supplemental agreement developed as a result of this Agreement is exclusively between the participating entity and awarded vendor. TIPS, its agents, TIPS members and employees shall not be made party to any claim for breach of such agreement.

#### **Survival Clause**

All applicable software license agreements, warranties or service agreements that were entered into between Vendor and Customer under the terms and conditions of the Agreement shall survive the expiration or termination of the Agreement. All Purchase Orders issued and accepted by Order Fulfiller shall survive expiration or termination of the Agreement.

#### **Legal obligations**

It is the responding vendor's responsibility to be aware of and comply with all local, state and federal laws governing the sale of products/services identified in this RFP and any awarded Agreement thereof. Applicable laws and regulations must be followed even if not specifically identified herein.

#### **Audit rights**

Awarded Vendor shall, at their sole expense, maintain appropriate due diligence of all purchases made by TIPS Member that utilizes this Agreement. TIPS and Region 8 ESC each reserve the right to audit the accounting for a period of three (3) years from the time such purchases are made. This audit right shall survive termination of this Agreement for a period of one (1) year from the effective date of termination. TIPS shall have authority to conduct random audits of Awarded Vendor's pricing that is offered to TIPS Members. Notwithstanding the foregoing, in the event that TIPS is made aware of any pricing being offered to eligible entities that is materially inconsistent with the pricing under this agreement, TIPS shall have the ability to conduct the audit internally or may engage a third-party auditing firm. In the event of an audit, the requested materials shall be provided in the format and at the location designated by Region 8 ESC or TIPS.

#### **Force Majeure**

If by reason of Force Majeure, either party hereto shall be rendered unable wholly or in part to carry out its obligations under this Agreement then such party shall give notice and fully particulars of Force Majeure in writing to the other party within a reasonable time after occurrence of the event or cause relied upon, and the obligation of the party giving such notice, so far as it is affected by such Force Majeure, shall be suspended during the continuance of the inability then claimed, except as hereinafter provided, but for no longer period, and such party shall endeavor to remove or overcome such inability with all reasonable dispatch.

#### Services

When applicable, performance bonds and payment bonds will be required on construction or labor required jobs. Awarded vendor will meet the TIPS member's local and state purchasing requirements. Awarded vendors may need to provide additional capacity as jobs increase. Bonds will not require that a fee be paid to TIPS. The actual cost of the bond will be a pass through to the TIPS member and added to the purchase order or Agreement.

#### **Scope of Services**

The specific scope of work for each job shall be determined in advance and in writing between TIPS Member and Awarded vendor. It is okay if the TIPS member provides a general scope, but the awarded vendor should provide a written scope of work to the TIPS member as part of the proposal. Once the scope of the job is agreed to, the TIPS member will issue a PO and/or an Agreement with the estimate referenced as an attachment along with bond and any other special provisions agreed to for the TIPS member. If special terms and conditions other than those covered within this solicitation and awarded Agreements are required, they will be attached to the PO and shall take precedence over those in the base Agreement.

#### **Project Delivery Order Procedures**

The TIPS member having approved and signed an interlocal agreement, or other TIPS membership document, may make a request of the awarded vendor under this Agreement when the TIPS member has services that need to be undertaken. Notification may occur via phone, the web, email, fax, or in person.

Upon notification of a pending request, the awarded vendor shall make contact with the TIPS member as soon as possible, but must make contact with the TIPS member within two working days.

#### **Scheduling of Projects**

Scheduling of projects (if applicable) will be accomplished when the TIPS member issues a purchase order that will serve as "the notice to proceed". The period for the delivery order will include the mobilization, materials purchase, installation and delivery, design, weather, and site cleanup and inspection. No additional claims may be made for delays as a result of these items. When the tasks have been completed the awarded vendor shall notify the client and have the

TIPS member inspect the work for acceptance under the scope and terms in the PO. The TIPS member will issue in writing any corrective actions that are required. Upon completion of these items, the TIPS member will issue a completion notice and final payment will be issued.

#### **Support Requirements**

If there is a dispute between the awarded vendor and TIPS member, TIPS or its representatives will assist in conflict resolution or third party (mandatory mediation), if requested by either party. TIPS, or its representatives, reserves the right to inspect any project and audit the awarded vendors TIPS project files, documentation and correspondence.

#### **Incorporation of Solicitation**

The TIPS Request for Proposals or the Request for Competitive Sealed Proposals solicitation and all associated documents and forms made part of the solicitation process, including any addenda, that resulted in the execution of this agreement are hereby incorporated by reference into this agreement as if copied verbatim.

## **Special Terms and Conditions**

It is the intent of TIPS to Agreement with a reliable, high performance vendor to supply products and services to government and educational agencies. It is the experience of TIPS that the following procedures provide TIPS, the Vendor, and the participating agency the necessary support to facilitate a mutually beneficial relationship. The specific procedures will be negotiated with the successful vendor.

- Agreements: All vendor purchase orders and/or Agreements/agreements must be emailed to TIPS at tipspo@tips-usa.com. Should an agency send an order direct to vendor, it is the vendor's responsibility to forward the order to TIPS at the email above within 24 business hours and confirm its receipt with TIPS.
- <u>Promotion of Agreement</u>: It is agreed that Vendor will encourage all eligible entities to purchase from the TIPS Program. Encouraging entities to purchase directly from the Vendor and not through TIPS Agreement is a violation of the terms and conditions of this Agreement and will result in removal of the Vendor from the TIPS Program.
- <u>Daily Order Confirmation</u>: All Agreement purchase orders will be approved daily by TIPS and sent to vendor. The vendor must confirm receipt of orders to the TIPS member (customer) within 24 business hours.
- Vendor custom website for TIPS: If Vendor is hosting a custom TIPS website, then
  updated pricing must be posted by 1<sup>st</sup> of each month.
- <u>Back Ordered Products</u>: If product is not expected to ship within 3 business days, customer is to be notified within 24 hours and appropriate action taken based on customer request.

Term of Agreement is one year with renewal options for up to two additional years as provided in the solicitation.

### MASTER SERVICES AGREEMENT (MSA)

For valuable consideration, the receipt and sufficiency of which is acknowledged, the parties agree as follows:

### 1. Composition of Agreement.

This Master Services Agreement ("MSA"), along with any associated schedules which may include any Service Order(s) and/or Statement(s) of Work ("SOW") that refer to this MSA, the Terms and Conditions applicable to the specific Services ordered hereunder and the schedules/exhibits referenced within such Terms and Conditions, and together they shall constitute the entire agreement between the parties with respect to the services and will supersede all proposals and prior discussions and writings between the parties with respect thereto, (collectively the "Agreement"). This Agreement cannot be altered, amended or modified except in writing that is agreed to by an authorized representative of each party. Any term not defined in this MSA shall have the definition provided in the accompanying attachment or schedule(s).

### 2. Definitions.

- (a) "Billing Commencement Date" shall be the date defined in the applicable Terms and Conditions attached hereto:
- (b) "Fees" shall have the meaning set out in Section 4.1 of this MSA;
- (c) "Service Order" shall have the meaning ascribed in the applicable Terms and Conditions attached hereto:
- (d) "Services" shall mean the Services as defined in the applicable Terms and Conditions attached hereto:
- (e) "Service Levels" shall mean the Service Levels defined for the applicable Service in the Terms and Conditions:
- (f) "Statement of Work" or "SOW" shall have the meaning ascribed in the Terms and Conditions; and
- (g) "Term" has the meaning set out in the Service Order and/or SOW.

### 3. Delivery and Term.

- 3.1 <u>Delivery of Services</u>. Services are acquired from VAZATA by using Service Order(s) and/or SOW(s). Each Service Order and/or SOW shall be in VAZATA's standard form and must be executed by both VAZATA and Customer prior to becoming effective. Upon each Service Order and/or SOW becoming effective, it shall, along with the applicable Terms and Conditions and other schedules referenced therein, form a part of this Agreement and be governed by the terms and conditions contained herein.
- 3.2 <u>Term and Renewal</u>. Services for which the Service Order and/or SOW states a "Total Monthly Recurring Fee" shall commence on the Billing Commencement Date and shall continue until the end of the Term unless otherwise terminated as set forth in this Agreement. The Term for Services for

which the Service Order and/or SOW states a "Total Monthly Recurring Fee" shall continue until the end of the Term and shall be as set out in the Service Order and/or SOW for such Services.

### 4. Fees and Payment.

- 4.1 <u>Fees</u>. Fees shall include one or both, as may be applicable, of the Total Monthly Recurring Fee and Total Non-recurring Fee (defined as all Fees other than Monthly Recurring Fees) as stated in the Service Order and/or SOW. In consideration for VAZATA's delivery of the Services, Customer shall pay the Fees as follows:
  - (a) any Total Monthly Recurring Fee set out in the Service Order and/or SOW on a monthly basis on the first day of each month with payment due within thirty days of date of invoice, with invoicing to commence on the Billing Commencement Date. Any partial months shall be invoiced on a prorated basis; and,
  - (b) any non-recurring Fees, or one time Fees, are invoiced and due immediately upon receipt of invoice and shall be nonrefundable.
- 4.2 <u>Credit Worthiness</u>. VAZATA may at any time perform a credit analysis of Customer. Customer shall provide any credit information reasonably requested by VAZATA. Following such credit analysis, VAZATA may, in its sole discretion, require Customer to pay the total Fees, or any portion thereof, in advance of providing Services and/or require other assurances to secure Customer's payment obligations under this Agreement.
- 4.3 <u>Taxes</u>. In addition to the Fees, Customer shall be responsible for paying any applicable sales, use, excise, or similar sales taxes or assessments imposed upon the Services by any federal, state, or local government authority, exclusive of taxes based upon VAZATA's income or payroll.
- 4.4 <u>Interest and Delinquent Payment Handling Charge</u>. Interest shall begin to accrue on unpaid invoices on the thirty-first (31<sup>st</sup>) day after the date of each invoice at the rate of 1% per month (12% per year) until paid in full. VAZATA, in addition to all other rights and remedies available to it, may charge Customer a late fee equal to the greater of (1) five percent (5%) of the amount due under the delinquent invoice, or (2) \$250, to reimburse VAZATA for its costs and inconvenience incurred as a consequence of Customer's delinquency. In no event, however, shall the charges permitted under this Section 4.4 or elsewhere in this Agreement, to the extent they are considered to be interest under applicable law, exceed the maximum lawful rate of interest.
- 4.5 <u>Disputes</u>. (a) The Parties agree to use the dispute resolution procedures set forth in this section shall apply with respect to any controversy or claim arising out of or relating to this Agreement or its breach, except that either party may elect to seek relief from a court of competent jurisdiction for the following types of controversies or claims: (i) action seeking a temporary restraining order or injunction, or (ii) a suit to compel compliance with this dispute resolution process.
- (b) Notwithstanding the foregoing, Fees reasonably disputed by Customer (along with late fees attributable to such amounts) shall not be due and payable if, and only if, Customer:

- (i) pays all undisputed Fees on or before the date specified in section 4.1 hereof;
- (ii) presents a written statement of any billing discrepancies or other specific basis to dispute an invoice to VAZATA in reasonable detail, together with appropriate supporting documentation, no later than 10 days after the date of such invoice; and
- (iii) negotiates in good faith with VAZATA for the purpose of resolving such dispute within ten (10) days of submitting such written statement to VAZATA. In the event such dispute is mutually agreed upon and resolved in favor of Customer, VAZATA will issue a corrected invoice to Customer, and Customer shall pay in accordance with Section 4.1. In the event the dispute is not resolved by this process, the parties agree that the dispute shall be referred to the chief financial officers of each party (or similar level executive), who will attempt to settle the dispute by negotiation. If the dispute is not resolved within ten (10) business days from the date of such referral, the parties may elect to refer the dispute to mediation, or an alternative form of dispute resolution, provided that nothing in this clause shall prevent the parties commencing the remedies under section (c), below.
- 4.7 <u>Service Suspension</u>. VAZATA may, on the thirty-first (31<sup>st</sup>) day after the date any invoice, provide Customer with written notice of the suspension of the provision of all or any part of the Services, including but not limited to the Service Levels (the "Suspension Period") for so long as Customer has not paid the subject invoice in full, unless Customer makes payment in full within three business days of the written notice of suspension. In the event of a suspension of Services, the Term shall, subject to any right of Termination contained in the Terms and Conditions, be extended by an amount of time equal to that of the Suspension Period. Absent material breach of the Agreement by VAZATA, Customer will remain responsible for all Fees for the remainder of the Term in the event of termination by either party. The remedies provided to VAZATA in this section are in addition to any other remedies available to VAZATA at law or in equity (all of which remedies shall be distinct, separate and cumulative).

### 5. Warranties, Liability and Indemnity.

- 5.1 <u>VAZATA WARRANTY</u>. EXCEPT AS EXPRESSLY STATED IN THIS AGREEMENT, VAZATA MAKES NO WARRANTIES OF ANY KIND WHATSOEVER, EXPRESS OR IMPLIED, STATUTORY OR OTHERWISE, INCLUDING BUT NOT LIMITED TO ALL IMPLIED WARRANTIES OR CONDITIONS OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. CUSTOMER EXPRESSLY ACKNOWLEDGES THAT ALTHOUGH VAZATA USES COMMERCIALLY REASONABLE EFFORTS TO ENSURE THE PROTECTION OF CUSTOMERS DATA, VAZATA DOES NOT PROVIDE OR GUARANTEE ABSOLUTE SECURITY.
- 5.2 <u>Limitation of Liability</u>. Except for claims arising from Sections 5.3, 5.4 or 6 of this Master Services Agreement and any claims specifically exempted in any Terms and Conditions attached hereto, neither VAZATA nor Customer shall be liable to the other under the Agreement in connection with any single event or series of events for any cover, set-off, special, indirect, consequential,

exemplary or punitive damages including, but not limited to, lost profits, lost business revenue, lost or damaged data, failure to realize expected savings, or other commercial or economic loss of any kind even if the other party has been advised of the possibility of these losses or damages, and regardless of the form of action, whether in contract or tort, including negligence or based upon any other legal or equitable theory. Furthermore, Customer agrees that Customer's sole and exclusive remedy for VAZATA's failure to provide the Services in accordance with the applicable Service Levels shall be as set out in the applicable Terms and Conditions.

Notwithstanding anything to the contrary contained in this Agreement, in no event will VAZATA's liability to Customer, or to that of its directors, officers, employees or users of the Services exceed the Fees actually paid to VAZATA within the three (3) month period immediately preceding the date on which the cause of action arose.

- Prohibited Persons and Transactions. Customer and VAZATA (each, a "Representing Party") each represents and warrants to the other (i) that neither the Representing Party nor any person or entity that directly owns a ten percent (10%) or greater equity interest in it nor any of its officers, directors or managing members is a person or entity (each, a "Prohibited Person") with whom U.S. persons or entities are restricted from doing business under regulations of the Office of Foreign Asset Control ("OFAC") of the Department of the Treasury (including those named on OFAC's Specially Designated and Blocked Persons List) or under any statute, executive order (including Executive Order 13224 (the "Executive Order") signed on September 24, 2001 and entitled "Blocking Property and Prohibiting Transactions with Persons Who Commit, Threaten to Commit, or Support Terrorism), or other governmental action, (ii) that the Representing Party's activities do not violate the International Money Laundering Abatement and Financial Anti-Terrorism Act of 2001 or the regulations or orders promulgated thereunder (as amended from time to time, the "Money Laundering Act"), and (iii) that throughout the term of this Agreement the Representing Party shall comply with the Executive Order and with the Money Laundering Act.
- No Control. Customer acknowledges that VAZATA does not own or have any control over the content, availability, accuracy or any other aspect of any information, data, files, pictures or content in any form or any type ("Content") made accessible or available by or to Customer or Customer's end users through the use of the Services and VAZATA does not monitor the use of the Services by Customer or its end users except as provided in this Agreement.

### 6. Confidentiality.

6.1 <u>Confidential Information</u>. The parties acknowledge that it will may be necessary for each of them to disclose or make available to each other information and materials, including but not limited to business information concerning a party and its clients, specifications, research, software, trade secrets, discoveries, ideas, know-how, designs, drawings, flow charts, data, marketing plans and financial or business information that is disclosed whether orally visually or in a material form, (collectively the "Confidential Information") that may be confidential or proprietary or may contain valuable trade secrets, and that such information may already have been disclosed prior to the Commencement Date. Prior to disclosure, the disclosing party shall use reasonable efforts to designate

all Confidential Information by marking the information with the word "Confidential" or similar wording. However, Customer and VAZATA agree that, even if not so marked, any Customer Software, VAZATA Software, VAZATA Hardware, Customer Hardware, VAZATA tools, shall be deemed Confidential Information. The provisions of this Section 6 supersede any prior confidentiality agreements between the parties.

- 6.2 Non-Disclosure. Both during and after the Term each of the parties agrees:
  - (a) to use commercially reasonable efforts to protect the Confidential Information of the other party from unauthorized use or disclosure and to use at least the same degree of care with regard thereto as it uses to protect its own Confidential Information of a like nature;
  - (b) to use and reproduce the Confidential Information of the other party only as permitted under this Agreement or as needed to perform its duties hereunder; and,
  - (c) not to disclose or permit access to the Confidential Information of the other party to any third party, without the other party's prior written consent.
- 6.3 Exceptions. Information will not be considered to be Confidential Information if it:
  - (a) is already, or otherwise becomes, publicly known by third parties as a result of no act or omission of the receiving party;
  - (b) is lawfully received, after disclosure hereunder, from a third party having right to disseminate the information without restriction on disclosure;
  - (c) is furnished to others by the disclosing party without restriction on disclosure; or,
  - (d) can be shown by the receiving party to have been independently developed by such party prior to the execution of this Agreement.

### 7. Injunctive Relief.

The parties agree that any breach by either party or any of its officers, directors, or employees, of any provisions of Section 6 may cause immediate and irreparable injury to the other party and that, in the event of such breach, the injured party will be entitled to seek injunctive relief as well as any and all other remedies at law or in equity without the necessity of posting any applicable bond, including but not limited to the recovery of reasonable attorney's fees.

### 8. General.

- 8.1 <u>Customer References</u>. Customer hereby grants VAZATA a non-exclusive, non-sublicenseable, royalty free, worldwide license to use Customer's trademarks, service marks, trade names, logos, or other commercial or product designations (collectively the "Marks") for the purposes of marketing and promoting VAZATA's services to the public. Customer may terminate VAZATA's right to use the Marks, in whole or in part, if the usage of such Marks does not adhere to Customer's then current standards for the use of such Marks.
- 8.2 <u>Headings</u>. Section headings are provided for convenience of reference only and do not constitute

part of the Agreement. Any references to a particular section of this Agreement shall be deemed to include reference to any and all subsections thereof.

- 8.3 <u>Severability and No Waiver</u>. If any provision of the Agreement is held to be invalid or unenforceable for any reason, the remaining provisions will continue in full force without being impaired or invalidated in any way. The parties agree to replace any invalid provision with a valid provision that most closely approximates the spirit and intent of the invalid provision. The waiver by either party of a breach of any provision of the Agreement will not operate or be interpreted as a waiver of any other or subsequent breach. This Agreement shall be read together with the Terms and Conditions and any Service Orders/SOW's to avoid inconsistent interpretations. However, in the event of irreconcilable conflicts, the following shall control, in order precedence: first, the Service Orders/SOW in question; second, the Terms and Conditions; and third, this MSA.
- 8.4 <u>Assignment</u>. Neither party may assign nor delegate any or all of its rights (other than the right to receive payment) or its duties or obligations hereunder without the consent of the other party, which consent shall not be unreasonably withheld or delayed, provided however, that either party may assign its duties or obligations hereunder without the need to obtain consent of the other party to an affiliate of such party or to a successor in interest to substantially all of the business of that party to which the Agreement relates as long as the affiliate or successor can demonstrate credit worthiness equal to or greater than the assigning party. An assignee of either party authorized hereunder shall be bound by all the terms of the Agreement and shall have all of the rights and obligations of the assigning party set forth therein. The provisions contained herein are for the sole benefit of the parties hereto.
- 8.5 <u>Independent Contractors</u>. The parties to the Agreement are independent contractors, and no agency, partnership, joint venture or employment relationship is intended or created hereby. Neither party shall have the power to obligate or bind the other party. Personnel supplied by VAZATA shall work exclusively for VAZATA and shall not for any purpose be considered employees or agents of Customer.
- 8.6 <u>Notices.</u> All notices, requests, demands or communications required or permitted hereunder shall be in writing, and delivered either personally or by facsimile or electronic transmission by email, or certified mail to the respective addresses as set forth below (or at such other addresses as shall be given in writing by either Party to the other). All notices, requests, demands or communications shall be deemed to have been given upon personal delivery or on the Business Day following the date of the facsimile or electronic transmission, or when received (or delivery is refused) if sent by certified mail.

- 8.7 <u>Governing Law, Jurisdiction and Venue</u>. The Agreement created hereunder shall be deemed to have been made in, and shall be construed pursuant to the laws of the State of Texas and any action or proceeding arising out of or related to this Agreement shall be brought only in the courts of such jurisdiction in Dallas County, Texas. The parties hereby consent to such jurisdiction and venue.
- 8.8 <u>Counterparts</u>. The Agreement, including all exhibits, attachments and schedules, may be executed in one or more counterparts, each of which shall be deemed an original and all of which shall be taken together and deemed to be one instrument. A photocopy, electronic or digital copy of a handwritten signature will be deemed to be an original signature for all purposes.
- Force Majeure" means an event, the cause of which is beyond the reasonable 8.9 control of the party affected thereby and which could not reasonably have been foreseen and provided against, including but not limited to, acts of god, strikes, lock outs or other labor or industrial disturbances, accidents, fires, explosions, weather conditions materially preventing or impairing work, inability to secure fuel, power, materials, contractors or labor, mechanical breakdown, failure of equipment or machinery, delays in transportation, wars, civil commotion, riot, sabotage, applicable legislation and regulations thereunder, interruption by government or court orders and future orders of any regulatory body of competent jurisdiction. Notwithstanding any other provision of the Agreement, if by reason of Force Majeure, either party is wholly or partly unable to perform certain elements of its obligations hereunder, it shall be relieved of those obligations to the extent, and for the period, that it is affected by Force Majeure, provided that the affected party gives the other party prompt notice of such inability. The party affected by Force Majeure shall use all reasonable efforts to remedy the situation and remove, so far as possible and with reasonable speed, the cause of its inability to perform, provided that there shall be no obligation on a party so affected to settle labor disputes or to test or to refrain from testing the validity of any order, regulation or law in any court having jurisdiction.
- 8.10 <u>Non-Solicitation</u>. Both VAZATA and Customer agree that during the Term of this Agreement and for a period of 1 year following the expiration or termination hereof, neither party shall, directly or indirectly, hire or offer to hire or entice away or in any other manner persuade or attempt to persuade any officer, employee, agent, or customer of the other party to discontinue his or her or its relationship with the other party.
