a Department of Texas Education Service Center Region 8 for TIPS RCSP 211001 Job Order Contracting

General Information

The Vendor Agreement ("Agreement") made and entered into by and between The Interlocal Purchasing System (hereinafter referred to as "TIPS" respectfully) a government cooperative purchasing program authorized by the Region 8 Education Service Center, having its principal place of business at 4845 US Hwy 271 North, Pittsburg, Texas 75686. This Agreement consists of the provisions set forth below, including provisions of all Attachments referenced herein. In the event of a conflict between the provisions set forth below and those contained in any Attachment, the provisions set forth shall control.

The Vendor Agreement shall include and incorporate by reference this Agreement, the terms and conditions, special terms and conditions, any agreed upon amendments, as well as all of the sections of the solicitation as posted, including any addenda and the awarded vendor's proposal. Once signed, if an awarded vendor's proposal varies or is unclear in any way from the TIPS Agreement, TIPS, at its sole discretion, will decide which provision will prevail. Other documents to be included are the awarded vendor's proposals, task orders, purchase orders and any adjustments which have been issued. If deviations are submitted to TIPS by the proposing vendor as provided by and within the solicitation process, this Agreement may be amended to incorporate any agreed deviations.

The following pages will constitute the Agreement between the successful vendors(s) and TIPS. Bidders shall state, in a separate writing, and include with their proposal response, any required exceptions or deviations from these terms, conditions, and specifications. If agreed to by TIPS, they will be incorporated into the final Agreement.

A Purchase Order, Agreement or Contract is the TIPS Member's approval providing the authority to proceed with the negotiated delivery order under the Agreement. Special terms and conditions as agreed to between the vendor and TIPS Member should be added as addenda to the Purchase Order, Agreement or Contract. Items such as certificate of insurance, bonding requirements, small or disadvantaged business goals are some of the addenda possible.

Terms and Conditions

Conflicts with RS Means Unit Price Book

If the terms of the solicitation referenced RS Means Unit Price Book occur, the RS Means Book shall control if it determines the legality of the solicitation award as it relates to the requisite Means Unit Price Book.

Freight

All quotes to members shall provide a line item for cost for freight or shipping regardless if there is a charge or not. If no charge for freight or shipping, indicate by stating "No Charge" or "\$0" or other similar indication. Otherwise, all shipping, freight or delivery changes shall be passed through to the TIPS Member at cost with no markup and said charges shall be agreed by the TIPS Member unless alternative shipping terms are agreed by TIPS as a result of the proposal award.

Warranty Conditions

All new supplies equipment and services shall include manufacturer's minimum standard warranty unless otherwise agreed to in writing. Vendor shall be legally permitted to sell, or an authorized dealer, distributor or manufacturer for all products offered for sale to TIPS Members. All equipment proposed shall be new unless clearly stated in writing.

Customer Support

The Vendor shall provide timely and accurate customer support for orders to TIPS Members as agreed by the Parties. Vendors shall respond to such requests within a commercially reasonable time after receipt of the request. If support and/or training is a line item sold or packaged with a sale, support shall be as agreed with the TIPS Member.

Agreements

Agreements for purchase will normally be put into effect by means of a contract, agreement, or purchase order(s) executed by authorized agents of the TIPS Member participating government entities, but other means of placing an order may be used at the Member's discretion. Vendor accepts and understands that when a purchase order or similar purchase document is sent from a customer through TIPS to the Vendor, TIPS is recording the purchase and verifying whether the purchase is within the parameters of the TIPS Contract only. Vendor agrees that TIPS is not a legal party to the purchase order or similar purchase document and TIPS is not responsible for identifying fraud, mistakes, or misrepresentations for the specific order. Vendor agrees that any purchase order or similar purchase document issued from a customer to Vendor, even when processed through TIPS, constitutes a legal contract between the customer and Vendor only. A Vendor that accepts a purchase order or similar purchase document and fulfills an order, even when processed through TIPS, is representing that the vendor has carefully reviewed the purchase order or similar purchase document for legality, authenticity, and accuracy.

Davis Bacon Act

Davis Bacon Act requirements will be met when Federal Funds are used for construction and/or repair of buildings or as otherwise required by applicable statute or regulation.

Other Wage Rates

Other wage rates may be required by some TIPS Members and acceptance of a project by the Vendor may require the Vendor to comply with the TIPS Member's required wage rate.

Tax exempt status

Most TIPS Members are tax exempt and the related laws of the jurisdiction of the TIPS Member shall apply.

Assignments of Agreements

No assignment of Agreement may be made without the prior written approval of TIPS. Payment for delivered goods and services can only be made to the awarded Vendor, Vendor designated reseller or vendor assigned company.

Disclosures

- Vendor and TIPS affirm that he/she, or any authorized employees or agents, has not given, offered to give, nor intends to give at any time hereafter any economic opportunity, future employment, gift, loan, gratuity, special discount, trip, favor or service to a public servant in connection with this Agreement.
- Vendor shall attach, in writing, a complete description of any and all relationships that might be considered a conflict of interest in doing business with the TIPS program.
- The Vendor affirms that, to the best of his/her knowledge, the offer has been arrived at independently, and is submitted without collusion with anyone to obtain information or gain any favoritism that would in any way limit competition or give an unfair advantage over other vendors in the award of this Agreement.

Term of Agreement and Renewals

The Agreement with TIPS is for approximately two (2) years with an option for renewal extension for an additional three (3) consecutive one (1) year terms. The first renewal extension year shall be automatic unless the awarded vendor notifies TIPS of its objection to the first additional one (1) year renewal extension. If TIPS offers the second and third one (1) year renewal extension terms, the vendor will be notified by email to the primary contact of the awarded Vendor and shall be deemed accepted by the Vendor unless the awarded vendor notifies TIPS of its objection to the additional term. TIPS may or may not exercise the available extension(s) provided in the original solicitation beyond the base term. Whether or not to offer the renewal extension years is at the sole discretion of TIPS.

"Start Date" for Term Calculation Purposes Only: Regardless of actual award/effective date of Contract, for Agreement "term" calculation purposes only, the Agreement "start date" is the last day of the month that Award Notifications are anticipated as published in the Solicitation.

Example: If the anticipated award date published in the Solicitation is August 27, 2020 but extended negotiations delay award until September 24, 2020 the end date of the resulting initial "two-year" term Agreement, (which is subject to an extension(s)) will still be August 31, 2022.

"Termination Date": The scheduled Agreement "termination date" shall be the last day of the month of the month of the Original Solicitation's Anticipated Award Date plus two years.

Example: If the original term is approximately two years, and the solicitation provides an anticipated award date of August 27, 2020, the expiration date of the original two-year term shall be August 31, 2022.

Extensions: Any extensions of the original term shall begin on the next day after the day the original term expires.

Example Following the Previous Example: If TIPS offers a one-year extension, the expiration of the extended term shall be August 31, 2023.

TIPS may offer to extend Vendor Agreements to the fullest extent the original Solicitation permits.

Total term of Agreement can be up to the number of years provided in the solicitation or as limited by statute.

Automatic Renewal Clauses Incorporated in Awarded Vendor Agreements with TIPS Members Resulting from the Solicitation and with the Vendor Named in this Agreement.

No Agreement for goods or services with a TIPS Member by the awarded vendor named in this Agreement that results from the solicitation award named in this Agreement, may incorporate an automatic renewal clause that exceeds month to month terms with which the TIPS Member must comply. All renewal terms incorporated in an Agreement by the vendor with the TIPS Member shall only be valid and enforceable when the vendor receives written confirmation by purchase order, executed Agreement or other written instruction issued by the TIPS Member for any renewal period. The purpose of this clause is to avoid a TIPS Member inadvertently renewing an Agreement during a period in which the governing body of the TIPS Member has not properly appropriated and budgeted the funds to satisfy the Agreement renewal. This term is not negotiable and any Agreement between a TIPS Member and a TIPS awarded vendor with an automatic renewal clause that conflicts with these terms is rendered void and unenforceable.

Shipments

The Vendor shall ship, deliver or provide ordered products or services within a commercially reasonable time after the receipt of the order from the TIPS Member. If a delay in said delivery is anticipated, the Vendor shall notify TIPS Member as to why delivery is delayed and shall provide an estimated time for completion of the order. TIPS or the requesting entity may cancel the order if estimated delivery time is not acceptable or not as agreed by the parties.

Invoices

The awarded Vendor shall submit invoices or payment requests to the TIPS Member participating entity clearly stating "Per TIPS Agreement # xxxxxxx." Each invoice or pay request shall include the TIPS Member's purchase order number or other identifying designation as provided in the order or contract by the TIPS Member. If applicable, the shipment tracking number or pertinent information for verification of TIPS Member receipt shall be made available upon request.

Pricing

Price increases will be honored according to the terms of the solicitation. However, the Vendor shall honor previous prices for thirty (30) days after written notification to TIPS of an increase, except any price changes related to the, then current, RS Means Unit Price Book is valid. Price of a specific Job Order Contract proposal to a TIPS Member shall not change within 60 days of date of proposal as a result of an updated RS Means Unit Price Book unless agreed by the TIPS Member. All pricing submitted to TIPS shall include the participation fee, as provided in the solicitation, to be remitted to TIPS by the Vendor. Vendor will not show adding the fee to the invoice presented to customer. Failure to render the participation fee to TIPS shall constitute a breach of this agreement and shall be grounds for termination of this agreement and any other agreement held with TIPS.

Participation Fees and Reporting of Sales to TIPS by Vendor

The Participation Fee that was published as part of the Solicitation and the fee published is the legally effective fee, along with any fee conditions stated in the Solicitation. Collection of the fees by TIPS is required under Texas Government Code §791.011 Et seq. Fees are due on all TIPS purchases reported by either Vendor or Member. Fees are due to TIPS upon payment by the Member to the Vendor, Reseller or Vendor Assigned Dealer. Vendor, Reseller or Vendor Assigned Dealer agrees that the participation fee is due to TIPS for all Agreement sales immediately upon receipt of payment including partial payment, from the Member Entity and must be paid to TIPS at least on a monthly

basis, specifically within 31 calendar days of receipt of payment, if not more frequently, or as otherwise agreed by TIPS in writing and signed by an authorized signatory of TIPS. Thus, when an awarded Vendor, Reseller or Vendor Assigned Dealer receives any amount of payment, even partial payment, for a TIPS sale, the legally effective fee for that amount is immediately due to TIPS from the Vendor and fees due to TIPS should be paid at least on a monthly basis, specifically within 31 calendar days of receipt of payment, if not more frequently.

Reporting of Sales to TIPS by Vendor

Vendor is required to report all sales under the TIPS contract to TIPS. When a public entity initiates a purchase with a TIPS Awarded Vendor, if the Member inquires verbally or in writing whether the Vendor holds a TIPS Contract, it is the duty of the Vendor to verify whether or not the Member is seeking a TIPS purchase. Once verified, the Vendor must include the TIPS Contract number on any communications and related sales documents exchanged with the TIPS Member entity. To report sales, the Vendor must login to the TIPS Vendor Portal online at https://www.tips-usa.com/vendors form.cfm and click on the PO's and Payments tab. Pages 3-7 of the Vendor Portal User Guide will walk you through the process of reporting sales to TIPS. Please refer to the TIPS Accounting FAQ's for more information about reporting sales and if you have further questions, contact the Accounting Team at accounting@tips-usa.com. The Vendor or vendor assigned dealers are responsible for keeping record of all sales that go through the TIPS Agreement and submitting same to TIPS. Failure to render the participation fee to TIPS shall constitute a breach of this agreement with our parent governmental entity, Texas Education Service Center Region 8, as established by the Texas legislature and shall be grounds for termination of this agreement and any other agreement held with TIPS and possible legal action. Any overpayment of participation fees to TIPS by a Vendor will be refunded to the Vendor within ninety (90) days of receipt of notification if TIPS receives written notification of the overpayment not later than the expiration of six (6) months from the date of overpayment and TIPS determines that the amount was not legally due to TIPS pursuant to this agreement and applicable law. It is the Vendor's responsibility to identify which sales are TIPS Agreement sales and pay the correct participation fee due for TIPS Agreement sales. Any notification of overpayment received by TIPS after the expiration of six (6) months from the date of overpayment will be non-refundable. Region 8 ESC and TIPS reserve the right to extend the six (6) month deadline to notify if approved by the Region 8 ESC Board of Directors. TIPS reserves all rights under the law to collect the fees due. Please contact TIPS at tips@tips-usa.com or call (866) 839-8477 if you have questions about paying fees.

Indemnity

The Vendor agrees to indemnify and hold harmless and defend TIPS, TIPS Member(s), officers and employees from and against all claims and suits by third parties for damages, injuries to persons (including death), property damages, losses, and expenses including court costs and reasonable attorney's fees, arising out of, or resulting from, Vendor's work under this Agreement, including all such causes of action based upon common, constitutional, or statutory law, or based in whole or in part, upon allegations of negligent or intentional acts on the part of the Vendor, its officers, employees, agents, subcontractors, licensees, or invitees. Parties found liable shall pay their proportionate share of damages as agreed by the parties or as ordered by a court of competent jurisdiction over the case. NO LIMITATION OF LIABILITY FOR DAMAGES FOR PERSONAL INJURY OR PROPERTY DAMAGE ARE PERMITTED OR AGREED BY TIPS/ESC REGION 8. Per Texas Education Code §44.032(f), reasonable Attorney's fees are recoverable by the prevailing party in any dispute resulting in litigation.

State of Texas Franchise Tax

By signature hereon, the bidder hereby certifies that he/she is not currently delinquent in the payment of any franchise taxes owed the State of Texas under Chapter 171, Tax Code.

Miscellaneous

The Vendor acknowledges and agrees that continued participation in TIPS is subject to TIPS sole discretion and that

any Vendor may be removed from the participation in the Program at any time with or without cause. Nothing in the Agreement or in any other communication between TIPS and the Vendor may be construed as a guarantee that TIPS or TIPS Members will submit any orders at any time. TIPS reserves the right to request additional proposals for items or services already on Agreement at any time.

Purchase Order Pricing/Product Deviation

If a deviation of pricing/product on a purchase order or contract modification occurs, TIPS is to be notified within five (5) business days of receipt of change order.

Termination for Convenience of TIPS Agreement Only

TIPS reserves the right to terminate this agreement for cause or no cause for convenience with a thirty (30) days prior written notice. Termination for convenience is conditionally required under Federal Regulations 2 CFR part 200 if the customer is using federal funds for the procurement. All purchase orders presented to the Vendor, but not fulfilled by the Vendor, by a TIPS Member prior to the actual termination of this agreement shall be honored at the option of the TIPS Member. The awarded Vendor may terminate the agreement with ninety (90) days prior written notice to TIPS 4845 US Hwy North, Pittsburg, Texas 75686. The vendor will be paid for goods and services delivered prior to the termination provided that the goods and services were delivered in accordance with the terms and conditions of the terminated agreement. This termination clause does not affect the sales agreements executed by the Vendor and the TIPS Member customer pursuant to this agreement. TIPS Members may negotiate a termination for convenience clause that meets the needs of the transaction based on applicable factors, such as funding sources or other needs.

TIPS Member Purchasing Procedures

Usually, purchase orders or their equal are issued by participating TIPS Member to the awarded vendor and should indicate on the order that the purchase is per the applicable TIPS Agreement Number. Orders are typically emailed to TIPS at tipspo@tips-usa.com.

- Awarded Vendor delivers goods/services directly to the participating member.
- Awarded Vendor invoices the participating TIPS Member directly.
- Awarded Vendor receives payment directly from the participating member.
- Fees are due to TIPS upon payment by the Member to the Vendor. Vendor agrees to pay the participation fee to TIPS for all Agreement sales upon receipt of payment including partial payment, from the Member Entity or as otherwise agreed by TIPS in writing and signed by an authorized signatory of TIPS.

Form of Agreement and Reporting

If a vendor submitting an offer requires TIPS and/or TIPS Member to sign an additional agreement, a copy of the proposed agreement must be included with the proposal to the TIPS Member. TIPS does not require a review a TIPS Member's Job Order contract TYPE AIA or other similar Contract provided by the TIPS Member. This clause does not relieve the Vendor from the responsibility to report the contract execution and the amount of the contract and any change orders.

Licenses

Awarded Vendor shall maintain, in current status, all federal, state and local licenses, bonds and permits required for the operation of the business conducted by awarded Vendor. Awarded Vendor shall remain reasonably fully informed of and in compliance with all ordinances and regulations pertaining to the lawful provision of goods or services under the Agreement. TIPS and TIPS Members reserves the right to stop work and/or cancel an order or terminate this or any other sales Agreement of any awarded Vendor whose license(s) required for performance under this Agreement have expired, lapsed, are suspended or terminated subject to a 30-day cure period unless prohibited by applicable statue or regulation.

Novation

If awarded Vendor sells or transfers all assets, rights or the entire portion of the assets or rights required to perform this Agreement, a successor in interest must guarantee to perform all obligations under this Agreement. A simple change of name agreement will not change the Agreement obligations of awarded vendor. TIPS will consider Contract Assignments on a case by case basis. TIPS must be notified within five (5) business days of the transfer of assets or rights.

Site Requirements (when applicable to service or job)

Cleanup: Awarded vendor shall clean up and remove all debris and rubbish resulting from their work as required or directed by TIPS Member. Upon completion of work, the premises shall be left in good repair and an orderly, neat, clean and unobstructed condition.

Preparation: Awarded vendor shall not begin a project for which TIPS Member has not prepared the site, unless awarded vendor does the preparation work at no cost, or until TIPS Member includes the cost of site preparation in a purchase order. Site preparation includes, but is not limited to: moving furniture, installing wiring for networks or power, and similar pre-installation requirements.

Registered sex offender restrictions: For work to be performed at schools, awarded vendor agrees that no employee of a sub-contractor who has been adjudicated to be a registered sex offender will perform work at any time when students are or reasonably expected to be present. Awarded vendor agrees that a violation of this condition shall be considered a material breach and may result in the cancellation of the purchase order at the TIPS Member's discretion. Awarded vendor must identify any additional costs associated with compliance of this term. If no costs are specified, compliance with this term will be provided at no additional charge.

Safety measures: Awarded vendor shall take all reasonable precautions for the safety of employees on the worksite, and shall erect and properly maintain all necessary safeguards for protection of workers and the public. Awarded vendor shall post warning signs against all hazards created by the operation and work in progress. Proper precautions shall be taken pursuant to state law and standard practices to protect workers, general public and existing structures from injury or damage.

Smoking

Persons working under Agreement shall adhere to local smoking policies. Smoking will only be permitted in posted areas or off premises.

Marketing

Awarded vendor agrees to allow TIPS to use their name and logo within website, marketing materials and advertisement subject to any reasonable restrictions provided to TIPS in the Proposal to the Solicitation. Any use of TIPS name and logo or any form of publicity, inclusive of press release, regarding this Agreement by awarded vendor must have prior approval from TIPS.

Supplemental agreements

The TIPS Member entity participating in the TIPS Agreement and awarded vendor may enter into a separate supplemental agreement or contract to further define the level of service requirements over and above the minimum defined in this Agreement i.e. invoice

requirements, ordering requirements, specialized delivery, etc. Any supplemental agreement or contract developed as a result of this Agreement is exclusively between the participating entity and awarded vendor. TIPS, its agents, TIPS Members and employees shall not be made party to any claim for breach of such agreement.

Survival Clause

All applicable software license agreements, warranties, service agreements or any supplemental agreement that were entered into between Vendor and TIPS or the TIPS Member Customer under the terms and conditions of the Agreement shall survive the expiration or termination of the Agreement. All Orders, Purchase Orders issued or contracts executed by TIPS or a TIPS Member and accepted by the Vendor prior to the expiration or termination of this agreement, shall survive expiration or termination of the Agreement, subject to previously agreed terms and conditions agreed by the parties or as otherwise specified herein relating to termination of this agreement.

Legal obligations

It is the responding vendor's responsibility to be aware of and comply with all local, state and federal laws governing the sale of products/services identified in this Solicitation and any awarded Agreement thereof. Applicable laws and regulations must be followed even if not specifically identified herein.

Audit rights

Due to transparency statutes and public accountability requirements of TIPS and TIPS Members', the awarded Vendor shall, at their sole expense, maintain appropriate due diligence of all purchases made by TIPS Member that utilizes this Agreement. TIPS and Region 8 ESC each reserve the right to audit the accounting of TIPS related purchases for a period of three (3) years from the time such purchases are made. This audit right shall survive termination of this Agreement for a period of one (1) year from the effective date of termination. In order to ensure and confirm compliance with this agreement, TIPS shall have authority to conduct random audits of Awarded Vendor's pricing that is offered to TIPS Members with 30 days' notice unless the audit is ordered by a Court Order or by a Government Agency with authority to do so without notice. Notwithstanding the foregoing, in the event that TIPS is made aware of any pricing being offered to eligible entities that is materially inconsistent with the pricing under this agreement, TIPS shall have the ability to conduct the audit internally or may engage a third- party auditing firm to investigate any possible non-complying conduct or may terminate the Agreement according to the terms of this Agreement. In the event of an audit, the requested materials shall be reasonably provided in the format and at the location designated by Region 8 ESC or TIPS.

Force Majeure

If by reason of Force Majeure, either party hereto shall be rendered unable wholly or in part to carry out its obligations under this Agreement then such party shall give notice and fully particulars of Force Majeure in writing to the other party within a reasonable time after occurrence of the event or cause relied upon, and the obligation of the party giving such notice, so far as it is affected by such Force Majeure, shall be suspended during the continuance of the inability then claimed, except as hereinafter provided, but for no longer period, and such party shall endeavor to remove or overcome such inability with all reasonable dispatch.

Choice of Law

The Agreement between the Vendor and TIPS/ESC Region 8 and any addenda or other additions resulting from this procurement process, however described, shall be governed by, construed and enforced in accordance with the laws of the State of Texas, regardless of any conflict of laws principles.

Venue, Jurisdiction and Service of Process

Any Proceeding arising out of or relating to this procurement process or any contract issued by TIPS resulting from or any contemplated transaction shall be brought in a court of competent jurisdiction in Camp County, Texas and each of the parties irrevocably submits to the exclusive jurisdiction of said court in any such proceeding, waives any objection it may now or hereafter have to venue or to convenience of forum, agrees that all claims in respect

of the Proceeding shall be heard and determined only in any such court, and agrees not to bring any proceeding arising out of or relating to this procurement process or any contract resulting from or any contemplated transaction in any other court. The parties agree that either or both of them may file a copy of this paragraph with any court as written evidence of the knowing, voluntary and freely bargained for agreement between the parties irrevocably to waive any objections to venue or to convenience of forum. Process in any Proceeding referred to in the first sentence of this Section may be served on any party anywhere in the world. Venue for any dispute resolution process, other than litigation, between TIPS and the Vendor shall be located in Camp or Titus County, Texas.

Bonding

Proposer must provide a current letter, issued on or after the date on which this Solicitation was posted, from their Surety company(ies) that specify the bonding capacity of the proposer. Bonding surety must be authorized to do business in the State of Texas and be listed on the Department of the Treasury's Listing of Approved Sureties (Department Circular 570) Bonding capabilities documentation must be scanned and uploaded to the "Response Attachments" BONDING section.

Professional Engineering and Architect's Services

Professional Engineering and Architect's Services are not permitted to be provided under this Agreement. Texas statutes prohibit the procurement of Professional Engineering and Architect's Services through a cooperative agreement.

Scope of Services

The specific scope of work for each job shall be determined in advance and in writing between TIPS Member, Member's design professionals and Vendor. It is permitted for the TIPS Member to provide a general scope description, but the awarded vendor should provide a written scope of work, and if applicable, according to the TIPS Member's design Professional as part of the proposal. Once the scope of the job is agreed to, the TIPS Member will issue a PO and/or an Agreement or Contract with the Job Order Contract Proposal referenced or as an attachment along with bond and any other special provisions agreed by the TIPS Member. If special terms and conditions other than those covered within this solicitation and awarded Agreements are required, they will be attached to the PO and/or an Agreement or Contract and shall take precedence over those in this base TIPS Vendor Agreement.

Project Delivery Order Procedures

The TIPS Member having approved and signed an interlocal agreement, or other TIPS Membership document, may make a request of the awarded vendor under this Agreement when the TIPS Member has services that need to be undertaken. Notification may occur via phone, the web, email, fax, or in person. Upon notification of a pending request, the awarded vendor shall make contact with the TIPS Member as soon as possible, but must make contact with the TIPS Member within two working days.

Scheduling of Projects

INTERNET SERVICES

The following is a description of the technologies and design of **PS LIGHTWAVE's** network and how it supports low latency, high availability Internet connections.

INTERNET CARRIERS

PS LIGHTWAVE is currently using Lumen Technologies, NTT America and Cogent as internet transit carriers. We have our own point of presence at each carrier facilities. Our network is designed to use multiple and redundant optical service ports from each provider, which is then connected into our routing core.

Lumen Technologies is a tier 1 provider with presence in over 500 markets and 60 countries. NTT America operates a global tier-1 IP backbone network spanning Asia-Pacific, North America, and Europe. Cogent is a tier 1 provider with 56,700 route miles of long-haul fiber and direct connectivity to over 5,800 AS (Autonomous Systems) networks.

PEERING

We are peering with Netflix, CyrusOne and Microsoft at the CyrusOne IX Houston Exchange, allowing our customers fast and high bandwidth access into these networks. We are peering with Microsoft at 100Gb.

INTERNET ROUTING CORE

We operate two border routers at separate carrier facilities with multiple 100G ports. Each border router has BGP feeds to all upstream transit providers as well as redundant connectivity into to our 100G Ethernet Metro Ring. The border routers provide their services to two Juniper MX 480 routers that are at different locations and configured as a virtual chassis. This virtual chassis configuration allows both routers to act as a single system with every component being redundant. A failure of a fiber patch, an optical port, a card or even a complete router has no service affecting consequences. Each of the Juniper MX routers are in a modern data center with N+1 redundant and generator backed up power feeds as well as separate redundant fiber optical entrances.

Connectivity between the two chassis is provided by direct fiber as well as optical fiber on our DWDM network. This ensures the highest redundancy. The connectivity to our two-border router is using LAG to ensure best resiliency. The redundancy of the system allows **PS LIGHTWAVE** to perform all needed hardware maintenance and software updates with minimal interruptions to your service.

METRO AREA NETWORK & LAYER 2 REDUNDANCY

A typical internet service is provided via an access port on our metro area network. We sometimes extend this access port to your location via a UTP or fiber-optical cable. Your router or firewall will connect to our layer 2 network and your traffic is then transported to our internet routing core. Most customer locations are connected to a hub, which is a central aggregation location on one



of our many metro area network rings. This added layer 2 redundancy in our metro rings further improves the customer experience and reliability of our services.

BGP & IPV6 SERVICES

Customers requiring BGP services will find that **PS LIGHTWAVE** has the knowledge and experiences to help you get connected. You can use BGP with IPv4 and/or IPv6 IP addresses and announce prefixes to **PS LIGHTWAVE**. We carry the full routing table, both on IPv4 and IPv6, from all our providers and with that, always give our customers the shortest path to their destination on the Internet. **PS LIGHTWAVE** is fully dual stacked to provide IPv4 and IPv6 to our customers.

CUSTOMER SERVICE

The **PS LIGHTWAVE** network is monitored 24/7/365 by our local Network Operations Center (NOC). Several monitoring tools are at our disposal to quickly identify problems and proactively work towards a restoration solution. Our NOC Team can track all field technicians and has completed fiber optic mapping system software training to create route detail and taper reports used to reduce the duration of outages and improve response time in cases of emergency. We measure latency to key sites on the Internet and traffic utilization on each link of our MAN fiber ring and scorecards rate performances during any outage and provide MTTR statistics. Each customer is provided with a traffic statistic webpage to track their usage.

The NOC is the main contact for all problems and service questions and is available via phone at **832-615-8000** or via email at **support@pslightwave.com**. **PS LIGHTWAVE** trains and staffs the NOC with qualified and highly motivated, customer-orientated employees.

SECURITY

PS LIGHTWAVE has invested in comprehensive security for its MAN fiber network. Network security is enforced in multiple stages:

Device Security: All network devices are configured with only the ports and services needed. Ports not requested or used by the customer are not a member of any configuration. Management access to switches is only possible from an internal management network. Management accounts are radius based and frequent password changes are mandatory. All configurations are stored on

a backup server in case a network device fails. All configuration changes are systematically recorded and emailed to an internal review group. Internal routing protocols are authenticated using encrypted handshakes. Unauthorized information cannot be injected into the network.

Internet Security: PS LIGHTWAVE monitors NetFlow statistics. Abnormal NetFlows are automatically alerted to the network operations groups. We have filter capabilities at each ingress port



to the network and can use access-list and other filtering capabilities in case of Virus/Trojan outbreaks. Abuse and security emails from Internet users are investigated. A Distributed Denial of Services (DDoS) mitigation service is available via one of our providers to mitigate active attacks



and can be implemented within a short time to filter traffic and return mitigated and clean traffic via private tunnel.

Physical security: All major ring nodes are in secure collocation and/or locked facilities. All devices are monitored 24x7x365. Should the NOC detect an alarm associated with a network device, personnel will immediately initiate contact with the customer. If the occurrence appears to be unrelated to a power disturbance or planned customer maintenance, **PS LIGHTWAVE** technicians are dispatched at that time.

95[™] PERCENTILE RULE

PS LIGHTWAVE will collect and record usage samples around the clock at frequent, regular intervals and calculate a monthly total which effectively disregards bursts of the top 5% usage within the total monthly sample, without incurring additional charges. The Customer will only incur additional charges, in one mbps increments, if the remaining 95% usage exceeds the contractual amount.


The amount of burstable bandwidth available for Internet usage is limited by only the Internet and the **PS LIGHTWAVE** switch at the Demarc. If the Customer at any time chooses to limit their Internet access to the contracted rate, **PS LIGHTWAVE** will rate limit the unique port at the **PS LIGHTWAVE** Demarc to accommodate The Customer's request.

DNS SERVICE

PS LIGHTWAVE is providing DNS services to its Customers with two separate name servers. These servers are connected at different point in our metro network at two different data centers to enhance the availability in case of a failure of either provider.

TRAFFIC REPORT

PS LIGHTWAVE monitories and reports bandwidth traffic via SNMP and provides this data via a **PS LIGHTWAVE** website. The website is located at http://usage.pslightwave.com/. Below is a






sample bandwidth report for an anonymous user. The blue and green separates incoming and outgoing bandwidth traffic. The standard view shows a daily, weekly, monthly, and yearly view of Internet usage. There is also a statistic for average usage and maximum usage for the period viewed. Moreover, we provide a zoom feature to look at a specific period on any of the graphs.

INTERNET SERVICE DIAGRAM

PS LIGHTWAVE's dedicated Internet access services use two100G MLX-8e border routers that feed two fully redundant Juniper MX routers that are located in different top tier datacenters. The Juniper MX480 routers are combined into one virtual chassis. The underlying network uses LAG and MLAG with direct fiber as well as DWDM optical rings. BGP ensures that upstream connectivity fails over in case of an Internet transit failure. The distribution layer 2 network uses ring topologies and enhances the service experience for our valued customers.





SERVICE LEVEL AGREEMENT

PS LIGHTWAVE has designed a maintenance and support plan to meet the needs of the Fiber Optic Network installed by **PS LIGHTWAVE**. The support plan is designed to provide on-site support response within two hours of notification, 24 hours per day, 7 days per week according to the following Service and Maintenance plan:

- **Network Availability: PS LIGHTWAVE** shall make all reasonable efforts to ensure 99.99% network availability of the Applicable Fiber.
- **Network Operations Center:** the **PS LIGHTWAVE** Support Plan is based on providing the TIPS' member support functions including problem tracking, resolution, and escalation support management on a 24x7x365 basis. The TIPS' member has the right, and is encouraged, to call concerning any problems that may arise relative to its connection with **PS LIGHTWAVE** provided services.
- Trouble Reporting: Upon interruption, degradation or loss of service, The TIPS' member may contact PS LIGHTWAVE by calling 832.615.8000. Minor problems can be reported through e-mail: support@pslightwave.com. Upon contact from the TIPS' member, the PS LIGHTWAVE support team will initiate an immediate response to resolve any TIPS' member issue. The TIPS' member will receive rapid feedback on trouble resolution, including potential resolution time.
- **Escalation:** In the event that service has not been restored in a timely manner, or the TIPS' member does not feel that adequate attention has been allocated, the TIPS' member can escalate the trouble resolution by request. A list of escalation contacts will be provided when implementation schedule is completed.
- **Resolution:** The TIPS' member will be notified immediately once the problem is resolved and will be asked for verbal closure of the incident.
- Trouble Reporting, Escalation and Resolution: At the time of contract execution, the TIPS' member agrees to provide PS LIGHTWAVE with an overview of its internal procedures for trouble reporting and resolution, including the TIPS' member's internal escalation contacts. The TIPS' member agrees to provide at least customary Tier 1 support to assist PS LIGHTWAVE in closing the incident report.
- **Measurement: PS LIGHTWAVE**'s stated commitment is to respond to any outage within two (2) hours with a four (4) hour restoration of service. Time starts from the time the TIPS' member contacts **PS LIGHTWAVE** and identifies the problem.
- Credits: The TIPS' member shall not receive a credit allowance for any outage caused by (i) the negligence or acts of it or its end user or agents; (ii) failure of power; (iii) the failure or malfunction of non-PS LIGHTWAVE equipment or systems; (iv) circumstances beyond PS LIGHTWAVE's control; (v) lack of PS LIGHTWAVE access to service premises; or (vi) a planned service outage, unscheduled emergency maintenance scheduled maintenance alteration or implementation.

The time shall start when a trouble ticket is opened and shall terminate when the ticket is acknowledged as resolved and closed by both the TIPS' member and **PS LIGHTWAVE**.

- Components Included (but not limited to): The following components are included in this Plan: PS LIGHTWAVE provided WAN Infrastructure components.
- Components Excluded: The following components are not included in the Plan:



- All components during downtime for PS LIGHTWAVE previously scheduled maintenance windows.
 PS LIGHTWAVE shall provide a five (5) day notification of all scheduled maintenance. Scheduled maintenance shall be performed between the hours of 12:00 am to 6:00 am local time.
- Any PS LIGHTWAVE components within the TIPS' member's Facility that cannot be corrected due
 to unavailability of the TIPS' member or inaccessibility of the premise.
- The TIPS' member equipment or content.
- **Reports:** Upon request, an incident report will be made available to the TIPS' member within five (5) working days of resolution of the trouble.



MAINTENANCE AND REPAIR PROCEDURE

- Network Operations Center: PS LIGHTWAVE's Maintenance, Repair and Support Plan is based on providing the TIPS' member support functions, including problem tracking, resolution, and escalation support management. The PS LIGHTWAVE Network Operations Center (NOC) is staffed on a 24x7x365 basis by trained PS LIGHTWAVE technicians. The TIPS' member has the right to and are encouraged to call concerning any problems that may arise.
- **2. Trouble Reporting:** Upon interruption, degradation or loss of service, the **PS LIGHTWAVE** NOC initiates contact based on the TIPS' member provided trouble reporting contact list, otherwise:
 - <u>A.</u> <u>Tier One Reporting</u>: As circumstances dictate, the TIPS' member contacts **PS LIGHTWAVE** by calling <u>832.615.8000</u> or e-mail: <u>support@pslightwave.com</u>. **PS LIGHTWAVE** Tier One personnel are trained to answer and respond to many questions and service-related issues. They will initiate a trouble ticket, if required, and send the ticket on to the correct **PS LIGHTWAVE** staff member.
 - B. Tier Two Reporting: PS LIGHTWAVE NOC personnel are trained to answer all service questions and resolve problems. This is a 24x7x365 operation. PS LIGHTWAVE NOC operators have a wide range of network management tools at their disposal, in addition to field crews to investigate outages, fully equipped line restoration crews, splicers, systems testers and network engineers. Whether the PS LIGHTWAVE NOC or the TIPS' member initiates the contact, the Network Operations Center opens a trouble ticket to track response. The PS LIGHTWAVE support team will initiate an immediate response to resolve any TIPS' member issue. The TIPS' member will receive rapid feedback on problem resolution, including approximate resolution time if there is a physical problem.
- 3. Escalation: In the event that service has not been restored in a timely manner or the PS LIGHTWAVE NOC operator desires additional support, the problem is escalated to Tier Three. In addition, if the TIPS' member does not feel that adequate attention has been allocated, The TIPS' member can request an escalation of the trouble resolution to Tier Three. PS LIGHTWAVE Tier Three personnel will contact the TIPS' member and will keep the TIPS' member updated on all resolution actions. If necessary, the TIPS' member will be provided with a list of PS LIGHTWAVE management personnel that may be contacted on a 24X7 basis.
