Our unique system is currently in use in the aviation industry for safe passenger boarding/de-boarding on the apron. This industrial grade system is ideal for directing foot traffic and blocking off areas for any situation where there are safety concerns. Other beneficial uses are establishing perimeters at COVID testing centers, construction sites, entry into and around parking lots, entry control at stadiums, schools, and other events that require temporary or permanent rope barriers that control the flow of patrons into and out of large facilities. The overall span of reflective yellow rope is between 144 ft and 170ft in total length.*
