Overview

For over 20 years, MASS Group has been providing Customers in both the private and public sectors with innovative, cloud-based software solutions that include: Asset Management, Fleet Management, RFID Asset Tracking & Reconciliation, Work Order Management, Inventory/Warehouse/Spare Parts Management, and Maintenance Management. Originally, its product was called FactoryServer and was first installed at one of the world's largest semiconductor manufacturers (which still uses it today). In 2007, the Company changed the product name to Traceability Made Easy® (TME®) to more accurately reflect its growing Customer base given the extensive work MASS Group was doing with various municipalities, public utilities, government agencies and other public entities.

The Company's flagship software product, TME®, has been sold to hundreds of Customers and used by tens of thousands of end users across a host of very complex and demanding industries. Common organizational challenges that TME® is used to resolve include increasing productivity by automating manual processes such as logging and tracking work orders, reducing unplanned downtime, managing preventative maintenance procedures, providing asset tracking and visibility to improve asset utilization, facilitating more informed fact based decision-making using data analytics, and enabling clients to more easily meet industry and regulatory compliance requirements.
